3. Quotation shall only be accepted in sealed envelope subscribing the NIQ No. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
4. **Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding, Installation Charges of the Machines (alongwith supply of required materials) and F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.**
5. The bidders participating in the quotation must provide the following document along with the price bids.
 - GST Registration Certificate.
 - Pan Card
 - Authorization Certificate
6. Materials must be delivered within 7 days after placement of supply Order.

7. The Milk Union reserves the right to cancel the Order if the supplier fails to supply the goods in due time or compromises with the quality of the goods.
8. Payment shall be made in NEFT/RTGS after 15 days of receipt of the bill along with the materials in good condition certified by competent authority.
9. The bids quoted shall remain for a period of 60 day(s).
