Work Order value Rs. 1,00,000/- should be executed by the party within the last three years and Work Completion certificate of from a competent authority should be submitted in support of the claim.

Statutory documents: Bidder shall submit latest GST Registration, copy of valid PAN

All the above-mentioned criteria and documents are mandatory and if the bidder fails to submit any of them, their bid will summarily be rejected.
