- 1. - 3. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. No quotation shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 4. Bidders should have valid GST Registration Certificate. In case of unregistered bidder GST amount shall be deducted from the bills.
- 5. The rate quoted in the bid is fixed for the Tenure of Contract and there shall be no variation in rate whatsoever and no claims regarding escalation of rates will be entertained during the contract period.
- 6. Price quoted by the bidder should be inclusive of all taxes and levies.

- 7. Time being the essence of the contract, call must be attended within 48 hours failure to which shall result in termination of the Contract.
- 8. Penal Clause: For delay in attending the call liquidated damage of 2% of the total cost of the bill per day shall be charged subjected to a maximum of 10% of the total cost of the bill and the amount shall be deducted as penal charges and no claim for exemption from the penalty shall be entertained.
- 9. Force Majeure: For delay in service for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as "Force Majeure" and penal provision will not be applicable.
- 10. Payment will be made in NEFT/RTGS within 45 days after satisfactory service certified by Concerned Sectional In-Charge and approved by Competent Authority followed by submission of bills. The bank details of the party are to be mentioned in the bills clearly.
- 11. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.
- 12. The Milk Union reserves the right to cancel the Contract if the Supplier fails to provide satisfactory/timely service.
- 13. The Milk Union reserves the right to cancel any/all bids or the entire process without assigning any reason thereof.
