- 3. Tenders shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No tenders shall be accepted through mail. Incomplete tenders are liable to be rejected.
- 4. Price quoted by the bidder should be inclusive of all taxes and levies packing, forwarding, installation and commissioning F.O.R (Freight on Road) The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.
- 5. The bidders participating in the tender must provide the following documents along with the price bids.
 - Authorization Letter from Principle Company
 - The catalogue of the Item
- 6. Quotations accompanying the documents as listed in serial no. 5 will be given preference. Incomplete quotations will summarily get rejected.

- 7. The bidders are required to mention their other terms and conditions while placing their bid.
- 8. Payment shall be made in Account Payee Cheque/NEFT/RTGS within 15 days of receipt of the bill along with the materials in good condition certified by competent authority.
- 9. If the material received is found faulty or possess any manufacturing defect as a result of poor workmanship within a month or two then it has to be replaced by the party.
- 10.Installation and Commission of the above material shall be the responsibility of the Tenderer.
- 11. The bids quoted shall remain for a period of 90 day(s).
- 12. The Milk Union reserves full right to accept or reject any tender/all tenders or to cancel the entire process without assigning any reason thereof.
