Extension Pipe supply and connection with 2" x 1½" Reducer between inlet header and valve– 8 sets. Replacement of leakage valves at condenser drain by new 1" Flanged End Globe Valves, Make: Super – 8 sets. 1" x 2' long. Extension Pipe supply and connection with 1½" x 1" Reducer between outlet header and valve – 8 sets. Replacement of 4" header connection at Condenser Inlet – 6.0 ft x 2 Nos. Supply and installation of 1½" extension pipe at condenser inlet – 2 ft. X 8 Nos. Supply and installation of 1" extension pipe at condenser inlet – 2 ft. X 8 Nos. Supply and installation of 2" condenser outlet header – 6' lg. x 2 Nos.(fixing at 2 ft. apart from present position).
