Technical bid submission:

The entire mandatory documents namely

Shall be placed in a sealed cover having written on top "NIT for Procurement of Spares for IAEC Boiler at Feeder Dairy".

Financial Bid Submission:

The financial offer of the bidder shall be submitted in a sealed cover having written on top "Financial Bid for **NIT for Procurement of Spares for IAEC Boiler at Feeder Dairy**". The financial offer of the bidder shall be in the following format:

written on its top as "BID for **NIT for Procurement of Spares for IAEC Boiler at Feeder Dairy**".

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited., Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101.

Validity of the bid: The bid once submitted will be valid for 60 days.

Delivery Period: The selected bidder shall deliver the materials within 7 days from the date of acceptance Purchase Order.

Other Terms & Conditions:

- 1. The bidders are required to submit their tender before last date and time of submission. No bids will be accepted for evaluation after last date and time of bid submission.
- 2. Partial/incomplete tenders are liable to be rejected. The tender documents should be properly indexed and signed and sealed by the bidder.
- 3. The rate quoted in the financial bid is fixed and there shall be no variation in rate whatsoever and no claims regarding escalation of rates will be entertained.

- 4. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding and transportation charges & FOR dairy.
- 5. Time being the essence of contact, materials must be delivered within 7 days after placement of Supply Order.
- 6. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in supply of goods subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the consignment arranged from the different source shall be deducted from the party.
- 7. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as "Force Majeure" and penalty clause will not be applicable.
- 8. Payment will be made in NEFT/RTGS after 30 days after delivery of goods and receipt at the Store Section of the Milk Union in good condition followed by submission of bills. The bank details of the party are to be mentioned in the bills clearly.
- 9. The Requisitioning Authority will certify the quality of goods received at the store. In case if any consignment is not conforming prescribed specification and quality, penalty shall be imposed and the cost will be deducted from the bill accordingly.
- 10. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
- 11. The Milk Union reserves the right to accept or reject any tender/all tenders or to cancel the entire process without assigning any reason thereof.
