2. For transaction failure, the bidder will again try for payment by going back to the first step.

### b) Payment through RTGS/NEFT:

- 1. On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
- 2. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account.
- 3. Once payment is made, the bidder Will come back to the e-Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.
- 4. If verification is successful, the fund will get credited to the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road for collection of EMD/Tender Fees.
- 5. Hereafter, the bidder will go to e-Procurement portal for submission of his bid.
- 6. But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.

#### **B. Refund/Settlement Process:**

- i. After opening of the bids and technical evaluation of the same by the Quotation inviting authority through electronic processing in the e-Procurement portal of the State Government, the Quotation inviting authority will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to IClCI Bank by the e-Procurement portal through web services.
- ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority.
- iii. Once the financial bid evaluation is electronically processed in the e Procurement portal, EMD of the technically qualified bidders other than that of the L1 and L2 bidders will be refunded, through an automated process, to the respective bidders' bank accounts from

If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurement portal, EMD of the L2 bidder will be refunded through an automated process, to his bank account from which he made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.
	v. As soon as the Ll bidder is awarded the contract (AOC) and the same is processed electronically in the e-Procurement portal –

#### **Terms and Conditions**

- 1. Bidders are advised to go through the clauses of the NIT properly and then quote their rates.
- 2. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/manufactured/fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The Bhagirathi Cooperative Milk Producers' Union Ltd. Reserves the right to cancel the N.I.T. at any time without showing any reason and no claim in this respect will be entertained.
- 3. The lowest successful bidder must keep liaison with the "Consent to Operate" Certificate issuing authority and arrange to conduct the boiler inspection. The lowest successful bidder shall also be responsible for generation of the permit for Consent of Operation of boilers issued from Competent Authority.
- 4. The Requisitioning Authority will certify the quality of goods received as per Annexure A at the store. In case if any material is not conforming prescribed specification and quality is supplied or installed then penalty shall be imposed and the cost will be deducted from the bill accordingly. Any material supplied or installed if found to be of substandard quality must be immediately replaced by the supplier else payment of the material shall not be released.
- 5. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in completion of job along with supply of goods necessary for completion of the job subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the consignment arranged from the different source shall be deducted from the party.

- 6. Place of Job: The office of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Berhampore, Murshidabad, Pin-742165, West Bengal.
- 7. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
- 8. In case of any dispute between the supplier and the Milk Union the decision of the Milk Union shall be the final and binding.
- 9. The rate quoted by the bidder shall be inclusive of all taxes Excise Duty, GST and other charges/ taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.
- 10. EMD of the lowest bidder shall be converted to Security Deposit and will be refunded after successful execution of the contract. EMD of unsuccessful bidders shall be refunded as per E-Tender norms mentioned above. EMD shall not carry interest.
- 11. Mode of transportation for the supply of the goods to our site will be arranged by the supplier.
- 12. Materials dispatched from the supplier until or unless reaches the Place of Delivery is the sole responsibility of the supplier. The Milk Union will not be responsible for any damage in transit and no claim in this regard will be entertained.
- 13. No escalation of rate shall be entertained during execution of the Contract. If the lowest bidder fails to supply the goods as per rate awarded in the contract the EMD shall be forfeited and no claim in this regard shall be entertained.
- 14. If the party fails/declines to execute the contract after the AOC is awarded the EMD shall be forfeited and no claim in this regard shall be entertained.
- 15. Payment shall be made within 30 days in NEFT/RTGS on successful completion of job and after obtaining Consent to Operate Certificate from Directorate of Boilers certified by the Concerned Sectional In-Charge and subsequent approval from Competent Authority. The party/agency/firm must submit 2 copies bill to the Milk Union.
- 16. Taxes will be deducted as per Govt. norms.
- 17. The undersigned reserves the right to accept or reject any tenders and to cancel the entire tender process without assigning any reason whatsoever.
