Last date and time of Quotation submission: 05.07.2019 at 1500 hrs

Estimate of the Work: NIL. Rate should be quoted by the bidder depending upon the prevailing market rate.

Bid Documents: Only the rate along with Trade License and GST registration certificate shall be submitted in sealed envelope mentioning "Bid for BOD incubator". The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited. Feeder Dairy Panchanantala, Berhampore, Murshidabad, Pin-742165

Validity of the bid: The bid once submitted will be valid for 90 days.

Delivery & Installation Schedule: The selected bidder must supply install and commission the item within 20-30 days from the date of issuance Purchase Order.

Other Terms & Conditions:

1. No cost escalation after receiving of bids shall be entertained.
2. Subletting of work is not allowed.
3. Liquidated damage of 0.5% per day with a maximum of 10% on the Total value of Purchase Order shall be imposed if there is any delay in supply of goods and the resultant amount shall be deducted from the bill.
4. Installation and Commissioning and Trial run shall be in the scope of the bidder.
5. Payment Terms:
 - 50 % payment shall be released after receiving the goods in good condition along with three (3) copies of Invoice and guarantee/warranty papers and operation manual.
 - 50% payment shall be released after successful installation, commissioning and trial run by the supplier or his authorized representatives duly certified by the officials of the Milk Union.
 - Payment shall not be released if there is a manufacturing defect in the material as a result of poor workmanship. If such situation occurs the supplied material shall be immediately replaced.
6. The Supplier must provide documents like operation brochure, guarantee/warranty papers during the time of supply of the equipment.
7. The supplier or his authorized personnel shall fully explain the working principle of the machine to the operators in presence of the officials of the Milk Union.
8. If there is any manufacturing defect immediately after the supply of the item as a result of poor workmanship the machine must be immediately replaced by the bidder.
9. If there is any delay in supply of the material during the scheduled time after the Work Order has been given the contract shall be deemed to be cancelled.

The bid inviting authority reserves the right to reject or cancel any bid or cancel the entire tender process at any point of time without assigning any reason whatsoever.
