The Bhagirathi Cooperative Milk Producers' Union Limited invites Online Tender (E-Tender) in Two bid system for procurement of 100,000 Kgs (100 Metric Ton) Skimmed Milk Powder (SMP) in craft paper bags of 25 kg to be delivered in consignments as required by Milk Union as per prescribed IS Standard and date of manufacture should not be before July 2020.

Earnest Money Deposit	The EMD amounting to Rs. 10,000/- should be deposited online through Net Banking, NEFT/RTGS in favour of The Bhagirathi Cooperative Milk Producers' Union Limited payable at Berhampore. EMD shall not carry interest.
	Tenderers will select the Tender to bid and initiate payment of pre- defined EMD for that tender by selecting from either of the following payments modes (vide Finance Department Memorandum no. 3975-F(Y) Dt. 28/07/2016) :
	1. Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of payment through ICICI Bank Payment Gateway.
	2. RTGS/NEFT in case of offline payment through bank accounts in any Bank.
	Payment procedure.
	a) Payment by Net Banking (any listed bank) through IClCI Bank Payment Gateway :
	1. On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction.
	2. Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.
	3. Bidder will receive a confirmation message regarding success/failure of the transaction.
	1. If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road, Kolkata for collection of EMD/Tender Fees.
	2. For transaction failure, the bidder will again try for payment by going back to the first step.
	b) Payment through RTGS/NEFT:
	1. On selection of RTGS/NEFT as the payment mode, the e-

Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
2. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account.
3. Once payment is made, the bidder Will come back to the e- Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.
 4. If verification is successful, the fund will get credited to the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road for collection of EMD/Tender Fees. 5. Hereafter, the bidder will go to e-Procurement portal for submission of his bid.
6. But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.
B. Refund/Settlement Process:
i. After opening of the bids and technical evaluation of the same by the Quotation inviting authority through electronic processing in the e-Procurement portal of the State Government, the Quotation inviting authority will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.
ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority.
iii. Once the financial bid evaluation is electronically processed in the e Procurement portal, EMD of the technically qualified bidders other than that of the L1 and L2 bidders will be refunded, through an automated process, to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the Quotation inviting authority. However, the L2 bidder should not be rejected till the LOI process is successful.
iv. If the L1 bidder accepts the LOI and the same is processed

	 electronically in the e-Procurement portal, EMD of the L2 bidder will be refunded through an automated process, to his bank account from which he made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority. v. As soon as the L1 bidder is awarded the contract (AOC) and the same is processed electronically in the e-Procurement portal – a) EMD of the L1 bidder for tenders of State Government offices will automatically get transferred from the pooling account to the State Government deposit head "8443-00-103-001-07" through GRIPS along with the bank particulars of the L1 bidder.
	b) EMD of the Ll bidder for tenders of the State PSUs/Autonomous Bodies/Local Bodies/PRIs, etc will automatically get transferred from the pooling account to their respective linked bank accounts along with the bank particulars of the L1 bidder. In both the above cases, such transfer will take place within T+1 Bank Working Days where T will mean the date on which the Award of Contract (AOC) is issued.
	vi. The Bank will share the details of the GRN No. generated on successful entry in GRIPS with the E-Procurement portal for updation.
	vii. Once the EMD of the Ll bidder is transferred in the manner mentioned above, Tender fees, if any, deposited by the bidders will be transferred electronically from the pooling account to the Government revenue receipt head "0070-60-800-013-27" through GRIPS for Government tenders and to the respective linked bank accounts for State PSU/Autonomous Body/Local Body/PRIs, etc tenders.
	viii. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD & Tender Fees (if any) were initiated.

	The bidder shall quote the rate online through Computer only in the space marked for quoting rate in the Bill of Quantities (BOQ). Only downloaded copies of the above documents, digitally signed by the bidder are to be uploaded (Excel file).
	In the BOQ only the Basic rate per kg of SMP shall be quoted FOR BCMPUL. GST is exempted as per Govt. Notification No. 30/2017-Integrated Tax (Rate) dated 22.09.2017. Bidders shall provide decleration whether supply is from West Bengal or other State from which GST shall be raised.

	2. Online Bid submission procedure
	i. Registration of Bidders : Agencies/Bidders who are interested in participating e-tenders will have to get enrolled & registered with the Government e-Procurement system. through logging on to <u>https://wbtenders.gov.in</u>
	ii. Digital Signature certificate (DSC) : Each bidders is required to obtain a class-II or Class-III Digital Signature Certificate (DSC) having Signing and Encryption certificate for submission of tenders from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount or any service provide as may be allowed by the Finance Department, Govt. of West Bengal.
	 iii. Tender Download: The bidders can search & download NIT & Tender Documents electronically from computer once he logs in to the e-Tendering portal <u>https://wbtenders.gov.in</u> using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.
	iv. Submission of Tenders: General process of submission, Tenders are to be submitted through online to the stipulated website in two folders, (one is Technical Bid & the other is Financial Bid) before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded duly digitally signed. The documents will get encrypted (transformed into non readable formats).
Award of Contract	The bidder selected after evaluation of financial bid by the tender committee will be given Award of Contract, subject to fulfillment of Terms and Conditions provided in the tender.

Terms and Conditions

- 1. Bidders are advised to go through the clauses of the NIT properly and then quote their rates.
- 2. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The Bhagirathi Cooperative Milk Producers' Union Ltd. Reserves the right to cancel the N.I.T. at any time without showing any reason and no claim in this respect will be entertained.
- 3. Supply of Goods: The supply of goods must be completed within 7 days from the date of issue of Purchase Order. Date of Supply Order will depend upon consumption of materials.
- 4. Time being the essence of the contact, materials must be delivered within 7 days after placement of Purchase Order. If materials are not delivered in scheduled time for which the production gets jeopardized liquidated damage of 0.5% of the total value Purchase Order of per day will be deducted subject to a maximum of 10% of the total Purchase Order Cost and the amount will be recovered from Security deposit and the bills. If the Milk Union makes an alternative arrangement for purchase due to delay/failure from your side the increase in cost of the purchase shall be deducted from the bidder.
- 5. Place of Delivery: The office of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Berhampore, Murshidabad, Pin-742165, West Bengal.
- 6. Conditional *and* incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender.
- 7. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
- 8. In case of any dispute between the supplier and the Milk Union the decision of the Milk Union shall be the final binding.
- 9. The rate quoted by the bidder shall be inclusive of all taxes Excise Duty, GST and other charges/ taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.

- 10. EMD of the lowest bidder shall be converted to Security Deposit and will be refunded after successful execution of the contract. EMD of unsuccessful bidders shall be refunded as per E-Tender norms mentioned above. EMD shall not carry interest.
- 11. Mode of transportation for the supply of the goods to our site will be arranged by the bidder.
- 12. Materials dispatched from the bidder until or unless reaches the Place of Delivery is the sole responsibility of the bidder. The Milk Union will not be responsible for any damage in transit and no claim in this regard will be entertained.
- 13. The Milk Union may cancel the Contract/Order if there is a decrease in the prevailing market rate.
- 14. The quality must conform to the prescribed norms. Any supply of goods not adhering to the specification shall be accepted/rejected on mutual inspection.
- 15. In case of new supplier the sample shall be tested by I/C Quality Control of the Milk Union. AOC shall be awarded if the sample is of acceptable quality. After receipt of consignment the Milk Union shall verify whether the consignment conforms the sample and prescribed standards. If the consignment is found to be of substandard quality the consignment shall be rejected and the contract shall be cancelled with immediate effect.
- 16. Loading and Unloading of the goods will be the responsibility of the bidder and no claim regarding this will be entertained.
- 17. Payment shall be made within 45 days on receipt of materials in good quality and quality test report of the supplied materials from Requisitioning Authority & on submission of bill in duplicate along with the received challans from the Competent Authority.
- 18. Taxes will be deducted as per Govt. norms.
- 19. The undersigned reserves the right to accept or reject any tenders and to cancel the entire tender process without assigning any reason whatsoever.
