Detailed Technical Specifications of Requirement:

A) Functional Requirements:

The Unit should be highly suitable for Coagulation of Milk to good quality Chhana required for Paneer Production and simultaneous extraction of Chhana with proper whey drainage from the system .

B) Design Requirements:

1) Capacity : 3000 ltrs

2) MOC : SS-304

3) Constructional Features:

- i. Type: Rectangular Open Top with Loose Lid (in 4 segments), Dimple Jacketed, and Insulated Tank mounted on 6 nos. Tubular Leg support (MOC SS 304) with adjustable Ball Feet.
- ii. Dimensions: Inner Shell 3600 mm(L) X 1500mm (W) X 750 mm (H); Bottom Slope 100mm towards Outlet; Thickness -(Inner Shell) 3mm , (Dimple Jacket) 2mm, (Outer Jacket) 2mm, (Loose Lid) 2mm.
- iii. Insulation Material: Glass Wool
- iv. Finish: All Welding Joints are to be ground smooth. All stainless Steel surfaces are to be polished to 150 grits. The joint curvatures with all inside corners should be of 25 mm radii and should bear good sanitary features.
- v. Accessories:
- vi. Chilled Water Connection: For cooling application, SS 304 water inlet of size 38mm dia with Flange and Counter Flange complete with ball valve shall be provided in the jacket.
- vii. Whey Outlet: Stainless Steel Cup Type outlet of 63.5 mm dia with butterfly valve fitted with Strainer of perforated Stainless Steel (MOC SS 316).
- viii. Drive Mechanism: 3 numbers of Agitator assembly with 0.5 HP Geared Motor , 30 RPM (Final RPM)

C) Manufacturing Code: The Paneer vat should be manufactured/fabricated with good Engineering practices and Workmanship.

D) Inspection and Testing: Bhagirathi Milk Union reserves the right to inspect the equipment during various stages of fabrication. The Following tests should be conducted by the manufacturer at their works:

1. Dye Penetration Test for all Stainless Steel Welding Joints.
2. Water- Fill up Test of Inner Shell for Water tightness and hyd. Test at 1.5 kg/sq cm for jacket.

The testing reports of fabrication should be submitted to the purchaser during Installation and Commissioning of the Unit.

E) Drawing :

Bidder should submit a GA Drawing of the Equipment with the Technical Bid giving details of the material of construction (MOC), details of the bought out items etc.

F) Installation and Commissioning:

All the Spares and components related to the Unit should be supplied, assembled, configured, commissioned and demonstrated for the purpose of high efficiency output . The bidder should provide all the necessary inputs for satisfactory output.

G) Warranty:

The Unit shall have a minimum warranty period of one year from the date of commissioning. Any issue regarding maintenance and repairing affecting unit performance within the mentioned warranty period should be resolved within 24 hrs. Any damage of spares due to poor workmanship of the bidder should be replaced free of cost within the mentioned period.

H) Training:

Operational & Cleaning SOPs (including leaflet on troubleshooting) should be well explained to the Milk Union operators for daily operation.

Terms and Conditions

1. The documents submitted by the bidders should be properly indexed & digitally signed.
2. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The Bhagirathi Cooperative Milk Producers' Union Ltd. Reserves the right to cancel the N.I.T. at any time without showing any reason and no claim in this respect will be entertained.
3. During evaluation the Committee may summon of the Bidders and seek clarification/information regarding bids within the stipulated time frame, their proposals will be liable for rejection.
4. Inspection of materials may be undertaken at the supplier's premises whenever necessary by the Tendering Authority/ any officer authorized by the undersigned.

5. The Bidders should have local arrangement (within West Bengal) for 'prompt after sale service' of the installed unit as and when required within warranty period free of cost. The service must be attended within 48 hours from the receipt of the information.
6. Warranty period shall be twelve months from the date of Commissioning of the installed unit from the principal company. Requisite document / warranty papers should be furnished by the Supplier after erection installation and commissioning of the machines. Machines not accompanied by warranty papers after commissioning will be rejected.
7. If the machine is not operational as a result of manufacturing defect or as a result of poor workmanship the machine has to be replaced by the bidder.
8. Supply, installation & commissioning of the ordered item with all accessories must be completed within 90 (ninety) days from the date of order. Trial – run of the whole unit will be done in presence of Milk Union's authorized personnel. Trial run report shall be submitted duly signed by the authorized personnel. Training of Operation & Maintenance to the operator will have to be imparted free of cost at the time of Commissioning & Trial-run.

IT IS OBLIGATORY FOR THE BIDDER TO NOTE THAT FAILURE TO MAINTAIN DELIVERY& I/C SCHEDULE OF ORDERED ITEM WILL HELD THE SUPPLIER RESPONSIBLE & ACTION WILL BE TAKEN STRICTLY AS PER TENDER RULES LAID DOWN HEREIN WITHOUT ANY PREJUDICE OR ANY SHORT OF PLEA WILL NOT BE CONSIDERED EXCEPT ANY INCIDENT OCCURRED "BY ACT OF GOD" OR NON READINESS OF SITE BY ANY MEANS MAY BE CONSIDERED ONLY.

9. **Penal Measure:** Time being the essence of the contract failure to supply the materials within due time or delay in installation and commissioning of the materials shall invite penalty.
 1. **Liquidated damages** of 0.5% per week subject to a maximum of 10% of the total cost of materials shall be charged if goods are not delivered in time and the amount will be deducted from the Security Deposit and bills submitted by the supplier.
 2. For violation of any terms and conditions of the contract the Bhagirathi Milk Union reserves the right to cancel the contract without assigning any reason thereof. On termination of Contract the Security Deposit will be forfeited and the resultant loss shall be recovered from the company. The subsequent company will be blacklisted for 3 years.
10. **Place of Delivery, Installation and Commissioning:** The office of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Berhampore, Murshidabad, Pin-742101, West Bengal.
11. Conditional *and* incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender.
12. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
13. The rate quoted by the bidder shall be inclusive of all taxes Excise Duty, GST and other charges/ taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.

14. EMD of the lowest bidder shall be converted to Security Deposit and will be refunded after successful execution of the contract. EMD of unsuccessful bidders shall be refunded as per E-Tender norms mentioned above. EMD shall not carry interest.
15. Mode of transportation for the supply of the goods to our site will be arranged by the bidder.
16. Materials dispatched from the bidder until or unless reaches the Place of Delivery is the sole responsibility of the bidder. The Milk Union will not be responsible for any damage in transit, loading or unloading and no claim in this regard will be entertained.
17. Loading and Unloading of the goods will be the responsibility of the bidder and no claim regarding this will be entertained.
18. Complete documentation like principal warranty papers, operation manuals, technical specifications and guarantee cards have to be furnished by the supplier.
19. Payment: Tax Invoice against all supplies is/are to be sent in **TRIPLICATE** and should invariably be submitted along with supply documents (Challan, e-waybill etc).
 - 50% will be released on receipt of acknowledged copy of challan/Invoice etc. of the whole unit in good condition at the specified site.
 - 40% payment will be released after successful Installation, Commissioning & Trial-run of the whole unit duly certified by the official of Union.
 - 10% after 1 year of successful installation and commissioning. This shall serve as Performance guarantee.
