Terms and Conditions:-

- 1. There should be no alteration in the tender documents Bidders are required to quote their rate in the specified specifications, terms, and conditions.
- 2. Bidders should possess Trade License and GST Registration Certificate.
- 3. In case of non GST registered Bidders the GST will be deducted as per Government Norms
- 4. Any other taxes and Levies will be deducted as per Govt. norms.
- 5. The Bidder must quote their rate inclusive of all taxes F.O.R. The Bhagirathi Milk Union.
- 6. Payment shall be made after **10 to 15 days** of delivery of the goods and receipt of the same at the store in the good condition.
- 7. Conditional or incomplete tenders are liable to be rejected.
- 8. Delivery of the material should be complete within 10 days after placement of Purchase Supply Order.
- 9. For delay in supply of goods within stipulated date and time a liquated damage of 0.5% will be imposed per week subject to maximum of 10% of the contract value and the amount will be deducted from the bill.
- 10. Violation of terms and condition or extreme delay in supply which may hamper the day to day activities of milk union may lead to the termination of contract after 3 remainders.
- 11. The Milk Union reserves full right to accept or reject any tender or cancel the entire tender process without assigning any reason thereof.
