The bid shall be submitted in two covers (Technical and Financial) which shall be further enclosed in a larger cover wherein it should be clearly superscribed on the envelope as "Annual Rate Contract for Engagement of Advertising Agency/Publicity Agent".

Validity of the bid: The bid once submitted will be valid for 365 days.

Other Terms & Conditions:

- 1. No cost escalation during the contract period shall be entertained.
- 2. Payment will be made within 30-45 days subject to submission of 3 copies of invoices along with original cut-out of 2 copies of the newspaper.
