#### **Other Terms & Conditions for Tender Auction**

- 1. Any conditional Tender will not be entertained and will be rejected.
- 2. The tenderer or his/her authorized person may inspect the standing crop to be auctioned on any working day during office hours (9.00 AM to 5.00 PM) starting from 10.12.2019 to 19.12.2019, with the permission of the authority.
- 3. If the tendered rates for the fruit crops in the above mentioned Orchard are found unjustified, it may not be accepted.
- 4. The tenderer/bidder should mark his signature in the bidding paper, without which the bid is liable to be rejected.
- 5. The sealed tender should reach this office by speed post/Courier service or by Hand before the last date and time of submission as scheduled above. The Bhagirathi Milk Union will not be responsible for any postal delay.
- 6. Tenders received beyond the last date and time will be summarily rejected.
- 7. Bidders/tenderers are at liberty to be present or authorize a representative to be present at the time of opening of tenders.
- 8. The Bhagirathi Milk Union reserves the right to accept or reject any of bids without assigning any reason thereof.
- 9. After qualifying the technical bid evaluation, the auctioneer proposing highest amount of bid as per financial bid evaluation, will be selected for award of contract.
- 10. An amount of Rs.40000/- will be deposited as Security amount either in cash or through bank draft in favour The Bhagirathi Cooperative Milk Producers' Union Ltd. payable at UBI, Bhagirathi Branch within 3 days from the date of award.
- 11. There should be no damage to the experimental material, trees or fencing of the boundary etc. In case there is any damage, the successful bidder would bear the cost of the damage fixed by the Milk Union.
- 12. Any Tax if applicable shall have to be paid by the successful bidder.
- 13.Only those crops which are auctioned will be allowed to be removed during office hours.
- 14. Firewood should not be used for cooking etc. in the orchard in any case. If any worker is found doing so the contractor will have to pay the penalty fixed by the Milk Union.
- 15. The contractor can not sub-lease the contract further.
- 16. The contractor will not be allowed to keep the family in the orchard and the worker may stay using temporary hut only for the purpose of guarding and nursing the crops.
- 17. Sale of the fruits within the orchard area is not permissible.
- 18. The Contractor will be required to intimate the name of the person with the full address and photocopy of identity for entering into the campus. Milk Union will not bear any cost on account of wages or others to the workers to be deployed by the contractor.
- 19. The contractor or his staff shall not indulge in any act which may hamper the peace or serenity of the campus, likely to be detrimental to the interests of the Milk Union.
- 20. The contractor or his worker shall not use the premises with other activities.
- 21. The successful tenderer/bidder would be responsible for maintenance of the auctioned plants. All the operations including manuring, watering, weeding, pruning, insect-pest management, bird scaring, guarding, harvesting and transportation will be carried out by the successful bidder at his/her own cost.

- 22. The successful tenderer/bidder would ensure proper maintenance of the orchard and will cooperate in all respect towards the same.
- 23. The successful tenderer/bidder should execute an agreement on non-judicial stamp paper of Rs.100/- within one week from the date of acceptance.
