4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.
5. The bidders participating in the quotation must provide the GST Registration Certificate along with the price bids.
6. Time being the essence of contract materials must be delivered within 7 days after placement of Supply Order.
7. Payment shall be made in NEFT/RTGS after 20 days of receipt of the bill along with the materials in good condition certified by competent authority.
