- 1. Two part bid which consists of Technical & Financial bid separately.
- 2. The applicants must submit their Trade License, PAN, P-TAX, GST Certificate, and other credentials, related to supply of similar items to any Govt. Department/Institution/Autonomous Bodies.
- 3. The applicant should upload scanned copies of all documents including Earnest Money Deposit (EMD) and Tender Processing Fees in technical folder.
- 4. The prospective applicant must have to deposit fixed Earnest Money ₹ 50,000.00 (Fifty Thousand) only & Tender Processing Fees ₹ 1,000.00 (One Thousand) only by Demand Draft of any nationalized Bank in favour of The Bhagirathi Cooperative Milk

Producers' Union Limited payable at **Berhampore**, **Murshidabad**. The scanned copy of EMD & Tender Processing Fees must be uploaded in technical folder.

- 5. The applicant should upload scanned copies of all documents *i.e.* Trade License, PAN, P-TAX, GST Certificate and other credentials. The intending bidder may download the tender document from the website https://wbtenders.gov.in directly with the help of Digital Signature Certificate. One copy of tender notice duly signed by bidder in each page is to be uploaded as consent to accept all terms and conditions as mentioned in tender notice.
- 4. The Earnest Money Deposit (EMD) along with copies of all relevant documents as mentioned above must be sent physically / through post to the office of The Bhagirathi Cooperative Milk Producers' Union Ltd in sealed envelope cover so as to reach this office before last date and time of submission.

(Financial quote must not be sent through post / physically).

- 5. The intending bidders are required to quote the rate online only. Financial Bid will contain rate of items only. No other document will be sent in the financial bid (Folder).
- 6. The rate quoted by the bidder will be fixed for a year. No escalation in the rate of the above materials would be considered during the contract period whatsoever. If the market price of the granules increases the party should inform it to the milk union.
- 7. Bidders are required to view the sample of the materials as required before quoting their rates at their own conveyance and no claim in this regard will be entertained.
- 8. The intending bidder is required to quote the rate in figures as well as in words in financial bid. Rate should be quoted per piece of item.
- 9. Payment will be made on receipt of quality report of the supplied materials from Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the Competent Authority.
- 10. The documents submitted by the bidders should be properly indexed & digitally signed.
- 11. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/manufactured/ fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The Bhagirathi Cooperative Milk Producers' Union Ltd. Reserves the right to cancel the N.I.T. at any time without showing any reason in the interest of the public and no claim in this respect will be entertained.
- 12. Supply of Goods: The supply of goods must be delivered within Delivery time from the date of issue of Purchase Order in consignments as decided by the Purchasing Authority time to time. The supplier should have the capacity to supply 10,000Kg poly film in a month.
- 13. Time being the essence of contract no variation shall be permitted in the delivery time as prescribed in the delivery schedule. If the bidder fails to supply and execute the work as per delivery schedule, The Bhagirathi Milk Union ltd. shall reserves the right to impose a liquated damage of 0.5% of the total contract value per week subject to a maximum of 10% of the contract value. In spite of several reminders and follow up if the party fails to execute the order and supply the material the contract will be cancelled and EMD will be forfeited.

- 14. One termination of contract, the EMD is liable to be forfeited and any of the resultant loss beyond EMD will be recovered from the contractor by regal means apart from forfeiture of any amount due to the contractor.
- 15. If there is any complain regarding the quality/ damage / short supply / failure of schedule date delivery etc. you will be responsible for replacement of the same or the cost of such item would be deducted from your bill amount.
- 16. The Milk Union reserves the right to terminate this contract if your performance is found unsatisfactory.
- 17. Place of Delivery: The office of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Berhampore, Murshidabad, Pin-742101, West Bengal.
- 18. Conditional *and* incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender
- 19. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders. In case the accepting Authority observes that the L1 bidder will not be able to supply all the materials in time, then the accepting authority reserves the right to split up offer to L2, L3 and others on L1 price for completion of time bound programme.
- 20. Before issuance of the SUPPLY ORDER, the tender inviting authority may verify the original credential(s) and/ or other document(s) of the lowest bidder with original documents, if found necessary. After verification, if it is found that the document(s) submitted by the lowest bidder is/are either manufactured or false, the work order will not be issued in favour of the said Bidder and earnest money will be forfeited.
- 21. You will be required to serve us at least 3 months notice in advance and earnest money will be forfeited, if you want to discontinue supplying us the materials as per the rate contract.
- 22. For any violation in specification as enclosed the order may be cancelled and resultant loss will be recovered from the supplier.
- 23. The rate quoted by the bidder shall be inclusive of all taxes packing, forwarding, Excise Duty & GST and other charges/ taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.
- 24. Mode of transportation for the supply of the goods will be arranged from your side.
- 25. Before acceptance of the Purchase Order you are required to enter into an agreement with The Bhagirathi Milk Union which will specify that the supply of goods will be as per specification and terms and conditions specified in the tender.
- 26. The undersigned reserves the right to cancel the tender at any point of time without assigning any reason thereof.
