# Eligibility Criteria & Mandatory Documents:

**Experience:** Bidder should have at least 3 (three) years of experience in Supply, Installation and Commissioning of Laminar Air Flow Device and BOD Incubator.

## **Statutory documents:**

- 1. Bidder shall submit latest GST Registration Certificate
- 2. Copy of valid PAN Card
- 3. Work Completion Certificate worth Rs 1.0 lakh in supply and installation of similar nature of goods.

The above-mentioned criteria and documents are mandatory and if the bidder fails to submit any of them, their bid will summarily be rejected.

**Submission of bids:** The bids will be submitted in offline mode.

## **Technical bid submission:**

The entire mandatory documents namely

- 1. GST Registration Certificate
- 2. Copy of valid PAN Card
- 3. Work Completion Certificate/ Work Order from competent authority worth Rs. 1.0 lakh

Shall be placed in a sealed cover having written on top **"BID for Supply, Installation and Commissioning of Laminar Air Flow Device and BOD Incubator"**.

Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as "BID for **Supply, Installation and Commissioning of Laminar Air Flow Device and BOD Incubator.**"

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited., Feeder Dairy, Panchanantala, Berhampore, Murshidabad.

Validity of the bid: The bid once submitted will be valid for 90 days.

**Delivery & Installation Schedule:** The selected bidder must supply, install and commission the items within 20-30 days from the date of issuing Work cum Supply Order.

## **Other Terms & Conditions:**

1. The bidders are required to submit their tender before last date and time of submission. No bids will be accepted for evaluation after last date and time of bid submission.

- 2. Partial/incomplete tenders are liable to be rejected. The tender documents should be properly indexed and signed and sealed by the bidder.
- 3. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding and transportation charges & FOR dairy.
- 4. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in completion of the Job subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills.
- 5. Installation and Commissioning and Trial run shall be in the scope of the bidder.
- 6. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as "Force Majeure" and penalty clause will not be applicable.
- 7. Payment Terms:
  - 50% payment shall be released after receiving the goods in good condition along with 3 (three) copies of Invoice and guarantee/warranty papers and operation manual.
  - 40% payment shall be released after successful installation, commissioning and trail run by the supplier or his authorized representatives duly certified by the officials of the Milk Union.
  - 10% after 6 months of successful commissioning. This shall serve as Performance Guarantee.
  - Payment shall not be released if there is regular failure in the operation of the supplied goods.
  - Payment shall not be released if there is a manufacturing defect in the material as a result of poor workmanship. If such situation occurs the supplied materials shall be immediately replaced.
- 8. The supplier must provide documents like operation brochure, guarantee/warranty papers during the time of supply of the equipment.
- 9. The supplier or his authorized personnel shall fully explain the working principle of the machine to the operators in presence of the officials of the Milk Union.
- 10. If there is any delay in supply of the material during the scheduled time after the Work cum Supply Order has been given the contract shall be deemed to be cancelled.
- 11. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
