Submission of bids: The bids will be submitted in offline mode.

Technical bid submission:

The entire mandatory documents namely

- 1. GST Registration Certificate
- 2. Copy of valid PAN Card
- 3. Certificate of Analysis / QC Certificate should be provided at the time of delivery

Shall be placed in a sealed cover having written on top "NIT for Procurement of Pre-mix for Vitamin A & D_2 for fortification of milk".

Financial Bid Submission:

The financial offer of the bidder shall be submitted in a sealed cover having written on top "Financial Bid for **NIT for Procurement of Pre-mix for Vitamin A & D₂ for fortification of milk**". The financial offer of the bidder shall be in the following format:

Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as "BID for **NIT for Procurement of Pre-mix for Vitamin A & D₂ for fortification of milk**".

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited., Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101.

Delivery Period: The selected bidder shall deliver the materials within 7 days from the date of acceptance Purchase Order.

Other Terms & Conditions:

- 1. The bidders are required to submit their tender before last date and time of submission. No bids will be accepted for evaluation after last date and time of bid submission.
- 2. Partial/incomplete tenders are liable to be rejected. The tender documents should be properly indexed and signed and sealed by the bidder.
- 3. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding and transportation charges & FOR dairy.
- 4. Time being the essence of contact, materials must be delivered within 7 days after placement of Supply Order. The party should have the capacity to supply the consignments required for 3 months in a single month if any exigency situation arises.
- 5. Material supplied by the party must conform to the prescribed specification as mentioned in the NIT. Material not conforming to the prescribed specification shall not be accepted.
- 6. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in supply of goods subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the consignment arranged from the different source shall be deducted from the party.
- 7. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as "Force Majeure" and penalty clause will not be applicable.
- 8. Payment will be made in NEFT/RTGS after 20 days after delivery of goods and receipt at the Store Section of the Milk Union in good condition followed by submission of bills. The bank details of the party are to be mentioned in the bills clearly.
- 9. The Requisitioning Authority will certify the quality of goods received at the store. In case if any consignment is not conforming prescribed specification and quality, penalty shall be imposed and the cost will be deducted from the bill accordingly.
- 10. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
- 11. The Milk Union reserves the right to cancel the Order if the Supplier fails to supply the goods in due time or compromises with the quality of the goods.
