- 9. Payment shall be made in NEFT/RTGS after 30 days of receipt of the bill along with the materials in good condition certified by competent authority.
- 10.If the material received is found faulty or possess any manufacturing defect as a result of poor workmanship within a month or two then it has to be replaced by the party.
- 11.In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
