b) Payment through RTGS/NEFT:	
1. On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filledchallan having the details to process RTGS/NEFT transaction.	
2. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT paymentusing his Bank account.	
3. Once payment is made, the bidder Will come back to the e-Procurement portal after expiry of areasonable time to enable the NEFT/RTGS process to complete, in order to verify the paymentmade and continue the bidding process.	
 4. If verification is successful, the fund will get credited to the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road for collection of EMD/Tender Fees. 3. Hereafter, the bidder will go to e-Procurement portal for submission of his bid. 	
4.But if the payment verification is unsuccessful, the amount will be returned to the bidder'saccount.	
B. Refund/Settlement Process:	
i. After opening of the bids and technical evaluation of the same by the Quotation inviting authoritythrough electronic processing in the e-Procurement portal of the State Government, the Quotationinviting authority will declare the status of the bids as successful or unsuccessful which will bemade available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.	
ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through anautomated process, the EMD of the bidders disqualified at the technical evaluation to therespective bidders' bank accounts from which they made the payment transaction. Such refundwill take place within T+2 Bank Working Days where T will mean the date on which information rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority.	
iii. Once the financial bid evaluation is electronically processed in the e Procurement portal, EMD of the technically qualified bidders other than that of the L1 will be refunded, throughan automated process, to the respective bidders' bank accounts from which they made thepayment transaction. Such refund will take place within $T+2$ Bank Working Days where T willmean the date on which information on rejection of financial bid is uploaded to the e-Procurementportal by the Quotation inviting authority.	
iv. If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurementportal and the information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.	
v. As soon as the Ll bidder is awarded the contract (AOC) and the same is processed electronically in the e-Procurement portal –	
 a) EMD of the Ll bidder for tenders of State Government offices will	

	automatically get transferred from the pooling account to the State Government deposit head "8443-00-103-001-07" through GRIPS along with the bank particulars of the Ll bidder.
	b) EMD of the Ll bidder for tenders of the State PSUs/Autonomous Bodies/Local Bodies/PRIs, etc will automatically get transferred from the pooling account to their respective linked bankaccounts along with the bank particulars of the L1 bidder.

	vi. The Bank will share the details of the GRN No. generated on successful entry in GRIPS with the E-Procurement portal for updation.

General Terms & Conditions

- 1. It is a two part bid which consists of Technical & Financial bid separately. The applicants must upload the credentials Statutory & Non Statutory documents in the Technical Folder. Technical & Financial quote must not be sent through post / physically. Bhagirathi may physically verify documents if required.
- 2. The intending bidders are required to quote the rate online only. Financial Bid will contain rate of items only. No other document will be sent in the financial bid (Folder).
- 3. Bidder should quote unit price of the material inclusive of all cost i.e. manufacturing, printing, packing, forwarding, loading the materials for delivery, transit insurance along with unloading the same in the store of the Milk Union inclusive of GST. **Cost of cylinder for bi coloured printing shall be quoted separately inclusive of all taxes and levies**. Cylinder developed by the successful bidder shall be the property of the Milk Union in the custody of the supplier. After successful execution of the Contract the cylinder has to be returned in good condition failure to which the cost quoted for the cylinder shall be deducted from the supplier.
- 4. The rate quoted by the bidder will be fixed for the quantity ascertained in this Tender Notice. No escalation in the rate would be considered.
- 5. **Payment shall be made within 15 days in NEFT/RTGS** on receipt of quality report of the supplied materials from Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the Competent Authority. If the material received does not conform to the above prescribed standard then the materials shall not be accepted or rejected after joint inspection.
- 6. The documents submitted by the bidders online should be properly indexed & digitally signed. The NIT must be signed by the bidder as a token of acceptance of the terms and conditions stipulated in this Tender.
- 7. **Materials must be delivered within 20 days after the Contract is awarded and design is finalized**. Time being the essence of contract no variation shall be permitted in the delivery time. If the supplier fails to supply within the aforesaid period, The Bhagirathi Milk Union Ltd. shall reserve the right to cancel the order besides forfeiture of Security Deposit and the loss shall be recovered from the party.
- 8. If there is any complaint regarding the **quality**/ **conformance to specification/damage** / **short supply** / **failure of schedule date delivery** etc. you will be responsible for replacement and if the Milk Union makes an alternative arrangement from another supplier the cost of such item would be deducted from the bill amount.
- 9. Place of Delivery: The Store Section of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Chaltia, Berhampore, Murshidabad, Pin-742165, West Bengal.
- 10. Conditional *and* incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender.
- 11. Subletting shall not be allowed under any circumstances.
- 12. Before issuance of the SUPPLY ORDER, the tender inviting authority may verify the original credential (s) and/ or other documents(s) of the lowest bidder with original documents, if found necessary. After verification, if it is found that the document(s) submitted by the lowest bidder is/are either manufactured or false, the work order will not be issued in favour of the said Bidder and security deposit will be forfeited.
- 13. Mode of transportation for the supply of the goods, loading and unloading of the materials must be arranged by the supplier.
- 14. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
