4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.
5. The bidders participating in the quotation must provide GST Registration Certificate along with the price bids.
6. Time being the essence of contract the job must be completed within 10 days after placement of Work Order.
7. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in completion of the job subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the contract arranged from the different source shall be deducted from the party.
8. Payment shall be made in NEFT/RTGS within 20 days after satisfactory completion of the job certified by competent authority.
9. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
