NOTICE INVITING TENDER FOR MVC PROJECT UNDER STATE DEVELOPMENT SCHEME, 2022-23

SEALED Tenders are invited in Two bid systems from bonafide, reliable, experienced & resourceful Transport Contractors, VehicleOwners, Transport Companies, Agencies having valid papers related to vehicle, valid agreement, driver and transporter to provide transport service through Commercial Licensed, Mahindra Bolero vehicles or equivalent category not more than 10 years old, for use as **Mobile Veterinary Clinic (MVC)** with option for customization as per requirement and suitable to enter into the narrow, brick or concrete roads of the villages of Murshidabad District for execution of Mobile Veterinary Clinic Project at **Domkal Block and Khargram Block** of Murshidabad district **upto 13**th **December- 2022**. The vehicle shall carry various veterinary medicines, equipment etc. along with Veterinary Doctor, Para-Vet and Driver-Cum- Attendant for conducting Animal Health Camps in various villages of the said two (2) blocks or as and when required by Bhagirathi Milk Union. The vehicles are to be stationed for Domkal Block at BLDO Office of Domkal or at the place as be mentioned in the WO and for Khargram Block at Karma Thirtha of Khargram Black (Nagar) or as mentioned in the WO.

Terms and Conditions:

- 1. The vehicle to be hired should be Commercial Licensed (as per Motor Vehicles Act) & Mahindra Bolero vehicles or equivalent category not more than 10 years old, preferably white in colour with option for customization as per requirement and suitable to enter into the narrow, brick or concrete roads of the villages within the Murshidabad district specially Kahrgram Block and Domkal Block.
- **2.** Vehicles will be required roam anywhere in the area of Murshidabad District / All Blocks.
- 3. Lowest bidder (Transporter) has to deposit an amount of Rs. 10,000/- in our cash counter as Security Deposit (Interest Free) for each vehicle at the time of acceptance of the Work Order. Security Deposit will be returned after successfully execution of contract.
- 4. Vehicles should move according to the fixed scheduled and time table (7 A.M approx) of the Officials of the concerned block in consultation with the Panchyati Raj Institution (PRI) or VO of BAHC / ABAHC in advance considering the availability of fund for this purpose.
- 5. The Log Book should be maintained by the VO, MVC. The designated officer will verify the Log Book on monthly basis.
- 6. Vehicles / Mobile Veterinary Clinic (MVC) should have containing for accommodation of 05 persons. There should be space for keeping various veterinary medicines, equipment and others requisites etc. as and when required.
- 7. The vehicle to be hired shall be in good condition and shall not be older than 10 (ten) years at the time of engagement in MVC and vehicles should have minimum mileage of 10 Km per litre of fuel. A licensed driver should be engaged along with the vehicle.

- 8. The vehicle should be kept clean, tidy and should have a name board and stickering / marked & fabrication should be done at all sides showing name "MOBILE VETERINARY CLINIC (MVC) UNDER THE STATE DEVELOPMENT SCHEME-2022-23, W.B, A.R.D DEPARTMENT or as per design provided by the authority, should be written over the body of the vehicles for easy visibility of the service users in local languishes. The vehicle should have a clearly visible commercial registration number.
- 9. The MVC vehicle may be fitted with GPS tracking system.
- 10. The vehicle should be regularly serviced and maintained so as to avoid any break down. In case of break down an alternative vehicle has to be arranged without compromising the services of MVC. In default suitable penalty will be imposed.
- 11. The vehicle should be insured with valid certificate of Commercial Registration by Govt. Transport Authority of the District, valid Pollution Clearance Certificate (PUCC) from the approved agency of Transport Department, Govt. of West Bengal and updated paid up Taxes, Insurance, fitness etc.
- 12. The repair and maintenance of the vehicles shall be responsibility of the owner/supplier / transporter of the vehicle. The vehicle shall be placed at the disposal of Veterinary Doctor of the MVC unit while on duty and shall be used exclusively for the public services. The vehicle will run minimum 20 days and maximum 26 days in a month irrespective of Govt. Holidays.
- 13. There must be only one quotation for a single vehicle, otherwise all the quotation papers for the same vehiclewill be rejected.
- 14. Any loss of life and property will be sole responsibility of the owner of the vehicle /supplier/ transporters / service provider.
- 15. The rate may be quoted on the basis of consolidated Dry Monthly Rate Contract including all expenses i.e. Tax, Driver, Mobil, Repair and Maintenance cost etc. except only fuel cost. Fuel Cost per km. run additionally will be quoted as per format provided.
- 16. An undertaking should be given by the owner/supplier/ transporter regarding non engagement of the same vehicle inany other organization/work at the same time or period.
- 17. In case the vehicle no more required or doesn't report on time on a regular basis the authority reserves the right to reject the work order / vehicle engagement letter / agreement and may engage vehicle form other source.
- 18. The engagement of the vehicle will be up to 13th December 2022, which may be extended with the approval from the competent authority. Either party may terminate / cancel the vehicle engagement letter / contract or withdrawn the vehicles by giving one (1) month prior notice to the each others, in default Security Deposit of Rs. 10,000/- will be forfeited without assigning any reason thereto.
- 19. For more details the interested party may contact the undersigned during office hour only.
- 20. The authority reserves the right to accept or reject any or all quotations without assigning any reasonthereof.
- 21. Non GST registered Person / agency may also be participated in the tender. In this case bidders should have to be mentioned that GST extra if applicable and will be paid by the Bhagirathi milk Union additionally. Otherwise GST will be deducted from the bill.
- 22. Income Tax Act, GST Act, M.V. Act, Insurance Act etc. will applicable and TDS will be deducted from the bill as per Law.
- **23.** Fuel rate per km will be increased and decreased in every month based on the average monthly fuel rate considering the mileage 10 k.m per liter of fuel.
- 24. Payment will be released after getting the fund from DAH&VS, WB under State Development Scheme, 2022-23.
