### NOTICE INVITING OFFLINE TENDER (TWO COVER SYSTEM)

Name of the work: Replacement of 125 KVA Transformer at Kandi Chilling Plant, Kandi, Murshidabad, West Bengal.

Offline tenders are invited by The Bhagirathi Cooperative Milk Producers' Union Limited in **TWO BID SYSTEM** from reliable, resourceful, bona fide and experienced firms / companies / individual contractors having requisite financial capability and sufficient experience in Replacement of Transformer.

# Scope of work for Replacement of 125 KVA Transformer

- 1. Disconnection and displacing 315 KVA Transformer from existing place at Feeder Dairy Berhampore to transport vehicle to be arranged by contractor.
- 2. Transportation of the 315 KVA Transformer from Feeder Dairy Berhampore to Kandi Chilling Plant.
- 3. Reconditioning and overhauling of 315 KVA Transformer along with replacement of gaskets and necessary insulating materials top up of transformer oil.
- 4. Disconnection and displacing 125 KVA Transformer from existing place at Kandi Chilling Plant and placement and connection of 315 KVA Transformer at Kandi Chilling Plant along with supply of termination kits.

Remarks: Total job has to be carried out with consultation with In-charge, Maintenance & In-charge, KCP of Bhagirathi Milk Union such that no or minimum electrical shut down is caused as dairy plant is an emergency unit.

Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as "BID for NIT for Replacement of 125 KVA Transformer at Kandi Chilling Plant."

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited., Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101.

**Validity of the bid:** The bid once submitted will be valid for 90 days.

**Work Completion Period:** The selected bidder shall be completed the work within 45 days from the date of issuing Work Order.

### **Other Terms & Conditions:**

- 1. The bidders are required to submit their tender before last date and time of submission. No bids will be accepted for evaluation after last date and time of bid submission.
- 2. Partial/incomplete tenders are liable to be rejected. The tender documents should be properly indexed and signed and sealed by the bidder.
- 3. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding and transportation charges & FOR Kandi Chilling Plant.
- 4. Time being the essence of contract; the job must be completed within 45 days from the date of issuing Work Order.
- 5. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in completion of the Job subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills.
- 6. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as "Force Majeure" and penalty clause will not be applicable.
- 7. 100% payment shall be made through NEFT/RTGS within 30 days after successful completion of the job against submission of 3 (three) copies of Invoice and duly certification by Competent Authority.
- 8. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
- 9. The Milk Union reserves the right to accept or reject any tender/all tenders or to cancel the entire process without assigning any reason thereof.
