- 6. Payment shall be made within 30 days in NEFT/RTGS on receipt of quality report of the supplied materials from Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the Competent Authority. If the materials received does not conform to the above prescribed standard then the materials shall not be accepted or rejected after joint inspection.

- 7. The documents submitted by the bidders online should be properly indexed & digitally signed. The NIT must be signed by the bidder as a token of acceptance of the terms and conditions stipulated in this Tender.
- 8. **Materials must be delivered within 7 days after the Contract is awarded**. Time being the essence of contract no variation shall be permitted in the delivery time.
