**GENERAL TERMS AND CONDITIONS:**

1. The Bhagirathi Co-operative Milk Producers' Union Ltd. will not accept any variations in conditions stipulated in the tender. Any suggestion in the tender, for any modification of the tender conditions will not be entertained and the conditional offer will render the tender invalid.
2. The tenderer can attend the pre bid meeting at the office of The Managing Director ,The Bhagirathi Cooperative Milk producers' Union Ltd. where the clarifications sought for by the tenderer will be given and the minutes of the pre bid meeting will be uploaded in the website.
3. The proposed vehicle which will be provided for Milk, Milk Can, Cattle Feed, Milk Products and other related materials transportation shall not be more than 5 years old and should be in good condition.
4. The rate quoted should be for commercial vehicle only.
5. The transport vehicle staff shall also be responsible for collecting Letter from Dairy Cooperative Society and submitting it to the Milk Union Office.
6. If the tenderer has already been blacklisted by any Government/ Government Under takings/ Co-operative societies, his tender will be rejected. In case information about such black listing comes to the knowledge of the Union after awarding of the tender, the contract will be terminated, liquidated damages levied, apart from taking penal action.

**Precautions:**

1. The tenderer must satisfy himself thoroughly about the geographical area to be covered, nature of work, local conditions and the requirement of the Union before submitting his tender.
2. The person signing the tender should be the Proprietor / Partner / Managing Director or any other person duly authorized to sign the tender document. In the latter case, authorization letter should be attached.
3. The tenderer should read every page and understand the implications fully and offer the tender only if he could discharge the obligations set out in the tender documents.

## **DRAFT AGREEMENT**

THIS AGREEMENT is made on this day of ..... At Berhampore between (1) "The Bhagirathi Co-operative Milk Producers' Union Ltd", having its registered office at Berhampore in the state of West Bengal.

AND

(2) .....(hereinafter)

Referred as the Transporter having permanent address at

..... (which expression shall, unless it be repugnant to the subject or context thereof, include its successors and assigns).

AND WHEREAS, The Milk Union is interested to hire transport vehicles of different carrying capacity for collection as well as distribution of milk, milk can, cattle feed, milk product and other relating materials from its Dairy Cooperative Society / operational areas to Feeder Dairy and Feeder Dairy to Dairy Cooperative Society/operational areas.

AND WHEREAS, The Transporter has agreed to provide and operate his vehicle having carrying capacity of .... Itrs. of milk with equivalent no of Cans, each Can carrying 40litres of milk & weight of one can is approximately 6.5 Kg for transportation and Collection of milk ,milk cans ,from Dairy Coop. Society as well as other distribution of milk and milk products produced and marketed by the Milk union in the same route/ operational areas.

Route Named .....in consideration of per kilometer rate of Rupees .....(Rupees.....only) per under the terms and conditions mentioned hereinafter.

### **NOW THEREFORE THIS AGREEMENT WITNESSES AS FOLLOWS:**

#### **Terms and Conditions:**

1. The Transporter( for the mentioned route) will be liable to collect and hand over the milk, milk products, Milk cans, milk testing equipments along with materials etc to the said Dairy Cooperative Society .The contract will be valid from \_\_\_\_\_to\_\_\_\_\_ and The Transporter will be liable for providing the service for the stipulated time period.
2. At the time of collection the transporter should record of the quantity of filled milk cans at union supplied format and it will be submitted to Union office in time. The transporter should also deliver the report of received milk from Dairy Cooperative Societies (Truck Sheet).

3. During the contract period, if the cost of fuel increases/decreases, by following the conventional rules of the Union, the Union will be liable to pay to the Transporter by increasing/decreasing the accepted rate per kilometre as per example provided below. Except the above mentioned point no change in per kilometer rate will be entertained during the contract period.

The payment for increase or decrease in fuel rate will be considered only if the average (monthly) rate of fuel increased or decreased by more than 50 paise per litre. The transporter has to produce an extra bill mentioning the extra amount due to the enhancement in fuel rate as well as in case of decrease in fuel rate, deduction will be done accordingly from the monthly bill of the transporter. The deducted or enhanced rate per kilometer will be calculated as per illustration given below :

For change in retail diesel price effective at Berhampore, the consumption of diesel for different carrying capacity vehicle will be considered as below.

| Can capacity of vehicle | Fuel consumption per litre |
|-------------------------|----------------------------|
| 150                     | 7 km.                      |
| 80 to 100               | 8 km.                      |
| 50 to 60                | 10 km.                     |

#### Illustrated example

If approved based rate during diesel rate Rs 70/- is Rs 15.00/Km for a route of 150 Km. If price of diesel is hiked by Rs.3/- . For a 80 to 100 can capacity vehicle, the calculation is as follows:

Diesel consumption for the vehicle =  $(150/8) = 18.75$  liter.

Increase in expenditure =  $(18.75 \times 3) = \text{Rs. } 56.25$

Increase in rate/Km =  $(56.25/150) = 0.375$

New per Km rate =  $(15+0.375) = \text{Rs. } 15.375/\text{Km}$

If approved based rate during diesel rate Rs 70/- is Rs 15.00/Km for a route of 150 Km. If price of diesel is decreased by Rs.3/- . For a 80 to 100 can capacity vehicle, the calculation is as follows:

Diesel consumption for the vehicle =  $(150/8) = 18.75$  liter.

Decrease in expenditure =  $(18.75 \times 3) = \text{Rs. } 56.25$

Decrease in rate/Km =  $(56.25/150) = 0.375$

New per Km rate =  $(15-0.375) = \text{Rs. } 14.625/\text{Km}$

This will be over & above existing rate.

3. The transporter shall carry the Milk, Milk Cans, Cattle Feed, Milk Testing Equipment, Letters, and Documents of Bhagirathi Milk Union according to the Time Table from pickup point to deliver the materials to the address/consignee/Milk Union or any other place as per instruction. If necessary the Transporter shall carry the Milk or Milk Product from Dairy to Agent/Society as per instruction of Milk Union to follow the Route & Time. If the Transporter is unable to perform such activities penalty will be imposed.
4. As per instructions these Milk, Milk Cans, Cattle Feed, Milk Testing Equipment, Letters and Documents are to be transported by milk vehicles to the milk union. The transporter of the Milk vehicle will be liable to maintain the record. If the transporter fails to fulfill the aforesaid responsibilities due to any reasons, which causes any economic loss or detrimental to the reputation of Milk Union then the transporter will be compelled to compensate the penalty amount imposed by the Milk Union which will be deducted from the monthly bill of the transporter.



5. If for the unavoidable circumstances the Milk Union is compelled to stop the milk collection at any Milk Route at any shift. Bhagirathi Milk Union will not be liable to pay the compensation. The Transporter will have to abide by such order, Bhagirathi will inform such instruction in advance.
6. The Transporter will be fully responsible for Milk Transportation. The Transporter shall also arrange for immediate replacement of the vehicle in the event of accident of the vehicle deployed by him and intimating both orally and writing to officials of Bhagirathi Milk Union and ensure that the service is not affected due to such accident. If the Transporter is unable to do it penalty will be imposed accordingly.
7. Transporter will have to affix this permanently- ON EMERGENCY DUTY BHAGIRATHI MILK UNION Name & Logo on the body of vehicle.
8. The Bhagirathi Milk Union shall have absolute right to check the vehicle at any time through its designated officials. In an unfortunate case of accident of the vehicle, liability will be activated according to the law of Motor vehicle Act.
9. The Transporter shall not use his vehicle for any other activities like transportation of materials other than that of the Bhagirathi Milk Union penalty will be imposed if the transporter is found to do so.
10. The Transporter shall maintain security Deposit Rs. 20,000/- Bhagirathi Milk Union No interest will be given on such amount. This security money to be deposited in cash or DD in the time of giving work order.
11. The Bhagirathi Milk Union shall have right to increase or decrease the No. of Society of Milk Route. After Implementation of such decision the payment will be done according to increase or decrease kilometer as per the fixed rate.
12. The transporter has to submit the transport bill (triplicate) within 5th day of the month. On this basis the bill amount will be paid within 15 days of the submission of bill. In case of failure to submit the bill within 5th day of succeeding month the Union will not be responsible for any delay in paying monthly bill. Income Tax will be deducted as per Govt. Norms.
13. The Bhagirathi Milk Union shall debar the Transporter or its staff for negligence of transportation of milk. If it is found to involve in the activities like theft, Fraud, dishonesty etc and for such case the loss shall be deducted from Transport Bill.
14. If necessary Bhagirathi Union shall have right to instruct to collect the Milk, Milk Cans and other materials from other Route according to the time table relating to that particular Route and to delivery this to the reception point. The payment will be done for such case as per the pre fixed rate. The Transporter shall be liable to compensate for the losses for the negligence of such activities if any.
15. Without prior permission of Milk Union the Transporter shall have no right to garage the Milk carrying vehicle at Union premises. For using the water Rs. 500/- penalty will be imposed each time.
16. The time table for milk collection shall be fixed by Bhagirathi Milk Union. The Transporter shall have to follow the scheduled time for collecting filled or empty Cans, Milk Product from receiving point.
17. No appeal will be entertained for increasing the transport rate within the contract period. If for any reason the transporter does not agree to move the vehicle and hence Milk Union incurs loss, the money shall be recovered from the transporter and penal action will be taken.
18. The Transporter shall be liable to submit the copies of all statutory documents required i. e. Vehicle Registration Certificate/Card, Tax Receipt, vehicle Fitness certificate, Road permit, Insurance, Driving License etc. renewed before its expiry to Milk Union without fail.
19. After settlement of tender if the Transporter is unable to supply the vehicle the Earnest Money of the Transporter will be forfeited and he shall be declared unfit to participating in tendering process of the Milk Union for next two years.

20. After getting the contract if the Transporter does not agree to move the vehicle within the period of contract The Bhagirathi Milk Union shall have absolute right to recover full losses from contractor and his Earnest Money will be forfeited.
21. If any kind of doubt arises regarding the contract or its briefing, both parties can appeal to the arbitrator. In this case the arbitrator will be Chairman / Special Officer of the Milk Union or any representative nominated by them .
22. The Bhagirathi Milk Union shall debar the Transporter and its staff if found involved in activities like theft. Fraud, dishonesty, bad behaviour with Union representative and unholy tie-up with any person. Suitable measures will be also be taken in accordance to law.
23. The transporter will be liable to follow the instructions provided by the Milk Union from time to time.
24. At the time of transporting full or empty Cans and Society/Milk Union related materials the transporter shall not be allowed to transport any other materials. If the Transporter is found to involve in such activities, penalty shall be imposed to the contractor.
25. The Vehicle must be insured according to insurance Act.
26. Without the permission of Milk Union the contractor shall not be allowed to change the type of vehicle other than the one specified in the contract. Sub contracting will not be allowed..
27. Force Majeure: For any unforeseeable circumstances like strike, lock out, Closer, Flood, Natural Calamities etc for which the Milk Union is Compelled to stop Milk Collection the Milk Union shall not be liable to compensate any charge or losses to the Transporter.
28. This is fully commercial contract and not the contract of appointment. There is no relation of staff and Employer within Union and Contractor. All the statutory liabilities shall be implemented time to time. The Transporter shall be compelled to abide by all the conditions..
29. The Transporter shall have to cover the Milk Cans by Jute Sack during the summer season if necessary as and when so decided by the Milk Union to be intimated in advance. The cost shall be borne by the transporter.
30. If the service of the transporter found unsatisfactory and violating any of the terms and conditions of the agreement the Milk Union reserves the right to terminate his/her contract without assigning any reason whatsoever. Due to any reason if the service of the transporter is no more required then Bhagirathi Milk Union will not be liable to pay any kind of demurrage to the The Transporter for the respective day or for the stipulated time period.
31. The vehicle used by the transporter to transport milk, milk can, cattle feed and milk products should comply with the Motor Vehicle act. In case of any kind of fine levied by the Govt. on the Transport vehicle the amount shall be borne by the transporter.
32. No loading or unloading charges will be paid to the transporter. In addition to this in case of Procurement enhancement, the transporter will have to engage an extra vehicle for which payment shall be made at the same rate or the rate decided by the Union.
33. The transporter shall collect the filled milk cans from Dairy Cooperative Society level and after unloading the filled cans it shall return to the Dairy Cooperative Society in schedule time. Any loss or damaged caused to the can any pilferage, theft during the process of transportation shall be recovered from the Transporter.
34. If the service of the transporter is not found satisfactory or it is adverse to the interest of the Milk Union then the Bhagirathi Milk Union may terminate the contract at any point of time, on termination of contract the Security Deposit will be forfeited.
