In case information about such black listing comes to the knowledge of the Union after awarding of the tender, the contract will be terminated, liquidated damages levied, apart from taking penal action.
- 10.BCMPUL reserves the right to accept or reject any or all tender wholly / partly without assigning any reason thereof.
- 11. Successful bidder has to complete the work within 15 days.
