5. Price quoted by the bidder should be inclusive of all taxes, levies and transportation charges & FOR dairy.

6. Minimum Warranty period should be 12 months. If there is any manufacturing defect the material should be replaced by the supplier.
7. Payment will be made in NEFT/RTGS in three phases:
  - 50% payment shall be made against delivery of material along with 3 copies of invoices operation manual and Warranty papers.
  - 45% against successful commissioning certified by concerned Sectional In-Charge and duly approved by competent authority.
  - 5% shall be released after 1 year from the date of successful commissioning. This 5% shall serve as Performance Guarantee.
