Annexure-A

- 1. To perform Gap analysis on the existing facilities/ documentation/ for departments/ sections falling under the defined scope, against the requirements of FSSM standard and produce a gap analysis report.
- 2. To plan together with management team of the Bhagirathi Milk Union on the ways to address the gap in order to develop the necessary documentation for standards compliances.
- 3. To maintain and update all records, procedures as required in standards and guide the management team all through its implementation.
- 4. To provide and develop customize internal training to workers and management team like Food Safety related training, housekeeping awareness, hygiene and sanitation awareness training, health & safety awareness training etc.
- 5. To develop and advise all departments and support an effective implementation of the standard requirements.
- 6. To offer close guidance in preparation and review of the final documents prior to completion of the audit.

- 7. To prepare FSMS manual, policies and procedure.
- 8. To assist and coordinate the required management review prior to completion of the audit.
- 9. To guide the management team in making an application for compliance audit.
- 10. To regulate coordination during the audit period of the Milk Union till completion successfully.
- 11.To guide and also make the correction, corrective action required to be taken against NCs and observations after audit completion.
- 12.All NCs closer report will be submitted to the certification body.
- 13. To submit audit report to the organization.
- 14. To develop all mandatory procedures as required in ISO 22000:2005 and guide the ISO project team on implementing the same.
- 15.To perform any other tasks to ensure for obtaining the certification of the department
