Eligibility Criteria & Mandatory Documents:

EMD: EMD of Rs. 10,000/- in favour of Managing Director, The Bhagirathi Milk Union in form of Demand Draft is to be submitted along with the Technical bid.

Experience: Bidder should have at least 3 (three) years of experience in Supply and Installation of CIJ printers. Work Order value Rs. 2,50,000/- should be executed by the party within the last three years and Work Completion certificate/Work Order from a competent authority should be submitted in support of the claim.

Statutory documents:

- 1. Bidder shall submit latest GST Registration
- 2. Copy of valid PAN.

All the above-mentioned criteria and documents are mandatory and if the bidder fails to submit any of them, their bid will summarily be rejected.

Submission of bids: The bids will be submitted in offline mode.

Technical bid submission:

All the mandatory documents namely

- 1. Work completion certificate/Work Order from competent authority worth Rs. 2.5 lakhs
- 2. EMD
- 3. GST Registration
- 4. Copy of valid PAN

Shall be placed in a sealed cover having written on top "Tender for Interior and Exterior Design and Renovation

Financial Bid Submission:

The financial offer of the bidder shall be in the following format:

Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as "BID for **Supply and Installation of CIJ Printer**".

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited.

Validity of the bid: The bid once submitted will be valid for 90 days.

Delivery & Installation Schedule: The selected bidder must complete the work with 20 days of the date of issuing Purchase Order.

Other Terms & Conditions:

- 1. Income tax and other mandatory tax deduction shall be done as per government norms before payment.
- 2. This office shall have the right and discretion to terminate the contract in the event of any sort of breach of contract.
- 3. Any black listed bidder shall not be allowed to participate in this NIT.
- 4. EMD of successful bidder shall be converted to security deposit and shall be released within 30 days after successful completion of the job. EMD of unsuccessful bidders shall be refunded. EMD shall not carry any interest.
- 5. No cost escalation will be entertained.

- 6. Payment will be made after satisfactory completion of work certified by the user and approved by competent authority within 20 days.
- 7. Subletting of work is not allowed.
- 8. Liquidated damage of 0.5% per day with a maximum of 10% on the Total value of Purchase Order shall be deducted if there is any delay in supply of goods.
- 9. Installation and Commissioning shall be in the scope of the bidder.
- 10. The Supplier must provide documents like operation brochure, guarantee, warranty papers during the time of supply of the equipment.
- 11. Annual Maintenance and Service contract must be included in the scope of work.

Technical Specification of CIJ Printer

- 1) In built user-friendly software with troubleshooting system related to Ink or Solvent failure or congestion within the system.
- 2) USB port compatibility.
- 3) Bar code features availability.
- 4) Filter change after min 3000 working hours.
- 5) Nozzle size within 50 to 60 microns for less consumption of ink.
- 6) Make up time up to 80 hrs.
- 7) AMC at least 4 calls a year.
- 8) Warranty of at least 1 year from the date of installation.
- 9) Necessary accessories like Machine Stand, Print Head Stand, Photocell etc. should be of original make and compatible with the company design.
- 10) Ink, Solvent and make up solution should be of original company make suitable to the machine use.
- 11) Additional features shall be acceptable.
