## NOTICE INVITING QUOTATION

The Bhagirathi Cooperative Milk Producers' Union Limited invites Offline Quotations from accredited SMS service providers for providing 5 lakh transactional SMS with API (Application Programming Interface) in account of the Milk Union as per terms and conditions mentioned hereunder:

- 1. Bidders are required to quote their lowest and best competitive rate/offer in sealed envelope addressing to the Managing Director of the Milk Union. The rate quoted must be inclusive of all taxes and levies. No extra incidental charges shall be provided.
- 2. The SMS may be sent from our in-house software therefore developer support must be provided by the supplier/service provider whenever required.
- 3. The bidder should have a portal through which the Milk Union can upload an excel sheet and can send bulk SMS.
- 4. Service provider has to abide by the rules and regulation framed by Telecom Regulatory Authority of India (TRAI) and Govt. of India and Govt. of West Bengal. Any violation in the rules framed by the Govt. shall not be attributed to the Purchaser.
- 5. As it a Govt. of West Bengal Project service provider must maintain absolute confidentiality regarding the SMS content.
- 6. The 5 lakh SMS must be credited to the Milk Union within 7 days after placement of Work Order failure to which the order shall stand cancelled.
- 7. 90% Payment shall be made in NEFT/RTGS in the bank account of the service provider within 10-15 days of receipt of 5 lakh SMS and Invoice of the same certified by the concerned official. Remaining 10% payment shall be released after 6 months which shall serve as performance guarantee.
- 8. Bidder should provide around 100-200 dummy sms for testing purposes.
- 9. Subletting shall not be allowed. Bidder must provide GST Registration Certificate along with the most competitive offer.
