- 4. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation.

#### 5. Validity of Quotation

Quotation shall remain valid for a period not less than 45 days after the deadline date specified for submission.

## 6. **Evaluation of Quotations**

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed; and
- (b) Conform to the terms and conditions, and specifications. GST in connection with sale of goods shall be taken into account in evaluation.

#### 7. **Award of contract**

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 8. Payment shall be made within 30 days from the date of delivery of the goods.
- 9. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.
- 10. You are requested to provide your offer latest by 16.00.hours till 15.10.2018
- 11. Supply should be done within 20 days after receiving the supply order.
