	Payment procedure.
	a) Payment by Net Banking (any listed bank) through IClCI Bank Payment Gateway :
	1. On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction.
	2. Bidder will make the payment after entering his Unique ID and password of the bank to process the transaction.
	3. Bidder will receive a confirmation message regarding success/failure of the transaction.
	2. If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road, Kolkata for collection of EMD/Tender Fees.
	3. For transaction failure, the bidder will again try for payment by going back to the first step.
	b) Payment through RTGS/NEFT:

Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
2. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account.
3. Once payment is made, the bidder Will come back to the e- Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.

If verification is successful, the fund will get credited to the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road for collection of EMD/Tender Fees.</li> <li>4. Hereafter, the bidder will go to e-Procurement portal for submission of his bid.</li> </ul>
5.But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.
B. Refund/Settlement Process:
i. After opening of the bids and technical evaluation of the same by the Quotation inviting authority through electronic processing in the e-Procurement portal of the State Government, the Quotation inviting authority will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.
ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through an automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority.
iii. Once the financial bid evaluation is electronically processed in the e Procurement portal, EMD of the technically qualified bidders other than that of the L1 will be refunded, through an automated process, to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the Quotation inviting authority.
iv. If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurement portal and the information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.
v. As soon as the Ll bidder is awarded the contract (AOC) and the same is processed electronically in the e-Procurement portal $-$

## **General Terms & Conditions**

- 1. Two part bid which consists of Technical & Financial bid separately.
- 2. The applicants must upload the credentials Statutory & Non Statutory documents in the Technical Folder. Nothing should be sent physically except the sample of each variant of containers.
- 3. Financial quote must not be sent through post / physically.
- 4. The intending bidders are required to quote the rate online only. Financial Bid will contain rate of items only. No other document will be sent in the financial bid (Folder).
- 5. Bidder should quote unit price of the material inclusive of all taxes and levies, conversion cost, loading and unloading F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. (Price should be based on Current price of HDPE granules + conversion cost). All taxes, levies, printing, colour, pigmentation, transport, loading, unloading shall come under 1 head i.e. Conversion Cost.
- 6. EMD of the lowest successful bidder shall be converted to Security Deposit and shall be released after 2 months of successful execution of the contract.
- 7. The intending bidder is required to quote the rate in figures as well as in words in financial bid. Rate should be quoted per piece of item.
- 8. Payment shall be made on receipt of quality report of the supplied materials from Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the Competent Authority after examination of each lot in NEFT/RTGS within 30 days of supply of materials. Payment may be delayed if there is any discrepancy or performance issue from the end of the supplier. The supplier should clearly understand his financial capacity before bid submission.
- 9. The documents submitted by the bidders online should be properly indexed & digitally signed.
- 10. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/ manufactured/ fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The Bhagirathi Cooperative Milk Producers' Union Ltd. Reserves the right to cancel the N.I.T. at any time without showing any reason and no claim in this respect will be entertained.
- 11. Supply of Goods: The goods must be delivered within delivery schedule which is 10-15 days from the date of Placement of Purchase Order. Materials ordered at a single Purchase Order must be sent in a single consignment. No materials shall be received in pro rata basis. The bidder should have the capacity to supply one third of the total quantity of annual requirement in a month. Bidder should clearly go through and understand this context before participating in the Tender. If in any case the bidder fails to adhere by this clause jeopardizing the material flow it shall invite penalty and subsequently the Contract shall be terminated and Security deposit shall be forfeited.

- 12. Packaging and Identification: The materials supplied should be packed properly and material quantity each pack should be clearly mentioned. Materials with improper packaging and identification shall not be accepted.
- 13. Time being the essence of contract no variation shall be permitted in the delivery time as prescribed in the delivery schedule. If the bidder fails to supply and execute the work in full or part of order as per delivery schedule, The Bhagirathi Milk Union Ltd. shall reserves the right to cancel the order besides forfeiture of Security Deposit.
- 14. One termination of contract, the Security Deposit is liable to be forfeited and any of the resultant loss beyond Security Deposit will be recovered from the contractor by deduction of the amount from bills or by legal means apart from forfeiture of any amount due to the contractor.
- 15. If there is any complaint regarding non conforamtion with quality/ damage / short supply / failure of schedule date delivery etc. the supplier will be responsible for replacement of the same or the cost of such item would be deducted from the bill amount, Security Deposit whichever applicable.
- 16. The Milk Union reserves the right to terminate this contract if your performance is found unsatisfactory.

#### 17. Place of Delivery: The office of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Chaltia, Berhampore, Murshidabad, Pin-742165, West Bengal.

- 18. Conditional *and* incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender
- 19. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
- 20. Before issuance of the SUPPLY ORDER, the tender inviting authority may verify the original credential(s) and/ or other document(s) of the lowest bidder with original documents, if found necessary. After verification, if it is found that the document(s) submitted by the lowest bidder is/are either manufactured or false, the work order will not be issued in favour of the said Bidder and security deposit will be forfeited.
- 21. Supplier is required to serve us at least 3 months' notice in advance and Security Deposit will be forfeited, if you want to discontinue supplying us the materials as per Tender.
- 22. The rate quoted by the bidder shall be inclusive of all taxes packing, forwarding, Excise Duty, loading and unloading & GST and other charges/ taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.
- 23. Mode of transportation, loading and unloading of goods will be arranged by the supplier and no claim in this regards shall be entertained. If in any cases loading and unloading is arranged by the Milk Union the subsequent cost shall be deducted from the bill.

- 24. The undersigned reserves the right to call a separate E-Tender by superseding this Tender at any time or cancel the tender or any bids at any point of time without assigning any reason thereof and no claim in this regard shall be entertained.
- 25. The Milk Union has the right to reject any party depending upon its poor performance in the past and no question in this regard shall be entertained.
- 26. **Price Variation Clause**: The Conversion cost (i.e. Design packaging, pigmentation, printing freight loading and unloading shall be fixed) but the rates are based on current rate of HDPE Granule for B6401, M110 or equivalent grade per MT (Any change of rate made by RIL/Haldia/Supreme/Equivalent at any time either upward or downward should be informed by the Supplier to the –Managing Director, BCMPUL when the Purchase Order is placed. The Purchase Order shall be placed on the actual price of HDPE granules (RIL/Haldia/Supreme/Equivalent) + conversion cost of materials. During bidding the rate shall be based on the current price of HDPE granules + conversion cost.

## **Technical Specifications**

Material of the Ghee Containers must be **High-density polyethylene** (**HDPE**) made from Food Grade Virgin Materials with outer cap, inside Aluminum foil as per our 4 coloured design. The word "BHAGIRATHI" is to be imposed on the lid and green Veg. mark on the body of the containers along with bar code and QR Code.

Bidder must submit samples of each variant physically before the last date and time of bid submission. Certificate of analysis from NABL Certified Laboratory must be uploaded in Technical Folder.

Bidders should strictly conform to the prescribed specification.
