### General Terms and Conditions:

1. The bidders are required to go through the Terms & Condition carefully, understand the requirement and then quote the most competitive rate in sealed envelope addressed to the Managing Director, The Bhagirathi Cooperative Milk Producers' Union Limited, Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101, WB.
2. The last date and time of submission of quotation documents is **06.02.2020**, 15.00 hours in the office of The Bhagirathi Cooperative Milk Producers' Union Limited.
3. Quotation shall only be accepted in sealed envelope subscribing the Memo No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.

5. The bidders participating in the quotation are requested to provide the following documents along with the price bids:
  - i. GST Registration Certificate
  - ii. Copy of valid PAN Card
  - iii. Work Completion Certificate/ Work Order from competent authority in supply and installation of similar nature of goods.
6. The selected bidder must supply, install and commission the item within 20-30 days from the date of issuing Work cum Supply Order.
7. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in completion of the job subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills.
8. Installation and Commissioning and Trial run shall be in the scope of the bidder.
9. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as “Force Majeure” and penalty clause will not be applicable.
10. Payment Terms:
  - 50% payment shall be released after receiving the goods in good condition along with 3 (three) copies of Invoice and guarantee/warranty papers and operation manual.
  - 40% payment shall be released after successful installation, commissioning and trail run by the supplier or his authorized representatives duly certified by the officials of the Milk Union.
  - 10% after 6 months of successful commissioning. This shall serve as Performance Guarantee.
  - Payment shall not be released if there is regular failure in the operation of the supplied goods.
  - Payment shall not be released if there is a manufacturing defect in the material as a result of poor workmanship. If such situation occurs the supplied materials shall be immediately replaced.
11. The supplier must provide documents like operation brochure, guarantee/warranty papers during the time of supply of the equipment.
12. The supplier or his authorized personnel shall fully explain the working principle of the machine to the operators in presence of the officials of the Milk Union.
13. If there is any delay in supply of the material during the scheduled time after the Work cum Supply Order has been given the contract shall be deemed to be cancelled.
14. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
15. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
