Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as “**BID for NIT for Supply of New Blower with 10HP Motor as well as Repairing Work of Existing Defective Blower Assembly at Feeder Dairy**”.

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers’ Union Limited., Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101.

**Validity of the bid:** The bid once submitted will be valid for 60 days.

**Supply/Job Completion Period:** Supply, Installation and Commissioning of the ordered item with all necessary repairing work must be completed within 45 days.

**Other Terms & Conditions:**

1. The bidders are required to submit their tender before last date and time of submission. No bids will be accepted for evaluation after last date and time of bid submission.
2. Partial/incomplete tenders are liable to be rejected. The tender documents should be properly indexed and signed and sealed by the bidder. Subletting is not allowed.
3. The rate quoted in the financial bid is fixed and there shall be no variation in rate whatsoever and no claims regarding escalation of rates will be entertained.

4. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding, transportation and any other incidental charges & FOR Feeder Dairy Berhampore. Transit Insurance charges shall be borne by you.
5. Time being the essence of contract, Supply, Installation and Commissioning of the ordered item with all necessary repairing work must be completed within 45 days.
6. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in supply of goods, installation and commissioning subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the consignment arranged from the different source shall be deducted from the party.
7. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as “Force Majeure” and penalty clause will not be applicable.
8. Payment Terms: Tax Invoice against all supplies is/are to be sent in Triplicate and should invariably be submitted along with supply documents.
  - 80% will be released on receipt of acknowledged copy of challan/invoice etc. of the whole unit in good condition at the specified site.
  - 20% payment will be released after successful installation, commissioning and trial run of the whole unit duly certified by the official of the Union.
9. The Requisitioning Authority will certify the quality of goods received at the store. In case if any consignment is not conforming prescribed specification and quality, penalty shall be imposed and the cost will be deducted from the bill accordingly.
10. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
11. The Milk Union reserves the right to accept or reject any tender/all tenders or to cancel the entire process without assigning any reason thereof.
