- 2. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 3. Price quoted by the bidder should be inclusive of all taxes levies, packing, forwarding, insurance charges, other incidental charges and F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited and in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.

- 4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
  - a. Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.
  - b. GST Registration Certificate / Unregistered dealers may also participate but the GST amount will be deducted from the bill amount if applicable.
  - c. Rate as per format in FORMAT A.

Failure to submit the above mandatory documents shall lead to rejection of the Quotation.

- 5. The service must be completed on scheduled date which will be informed you later and the propose vehicle which will be provided for transportation should be in good condition.
- 6. Payment shall be made in NEFT/RTGS within 7 days on receipt of the bill alongwith Service Completion Certificate, certified by competent authority.
- 7. In case there is any discrepancy/demurrage during shifting of tank, the Milk Union may impose a penalty and it will be deducted from your bill without assigning any letters.
- 8. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.
- 9. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
