General Terms and Conditions:

1. The bidders are required to go through the Terms & Condition carefully, understand the requirement and then quote the most competitive rate in sealed envelope addressed to the Managing Director, The Bhagirathi Cooperative Milk Producers' Union Limited, Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101 (WB).
2. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
3. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding stamping charges and F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited and in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.

4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
 - a. **Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.**
 - b. **GST Registration Certificate. If you are not GST registered holder, then GST amount would be deducted from your Bills.**
 - c. **Rate as per format in FORMAT – A.**

Failure to submit the above mandatory documents shall lead to rejection of the Quotation.

5. Validity of contract period between bidder and The BCMPU Ltd. shall be six months from the date of payment of 50% order value in advance.
6. Minimum number of calls covered will be two numbers inclusive of preventive and break down calls whenever required, apart from regular maintenance.
7. Your authorized Service engineer shall visit the milk union for corrective remedial maintenance.
8. In case of change of any spears parts the cost shall be borne by the Bhagirathi Milk Union.
9. 1st quarterly Payment shall be released against Proforma Invoice along with acceptance copy of the contract in NEFT/RTGS. Balance payment shall be released after completion of the contract and placement of Invoice duly certified by competent authority.
10. The Spares received if found to be of substandard quality shall be rejected upon mutual inspection. In case Spares does not conform to the acceptability standard of the Milk Union the material has to be replaced by the bidder within 7 days.
11. In case there is any discrepancy in standard of maintenance work the Milk Union may impose a penalty. In this case prior intimation shall be given to the bidder.
12. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.

The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
