- 1. - 3. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotation shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 4. The bidders participating in the Quotation are requested to provide GST Registration Certificate along with the price bids.
- 5. Price quoted by the bidder should be inclusive of all taxes levies.
- 6. The rate quoted in the bid is fixed for the Tenure of Contract and there shall be no variation in rate whatsoever and no claims regarding escalation of rates will be entertained during the contract period.
- 7. The authorized Service Engineer shall visit The Milk Union for corrective remedial maintenance (Breakdown maintenance) within the cost specified in the contract.
- 8. Notwithstanding anything contrary under this contract it is sole responsibility of the party to ensure that printer/systems are in good working order.
- 9. The maximum number of calls covered under this contract will be 06 [Six No (S.)] for each printer. 4 Preventive calls and 2 breakdown calls whenever required to do so.

- 10. The Bhagirathi Milk Union shall neither directly open, alter, try to tamper with nor in anyway do any act which will result in intruding with the internal operation of the system and peripheral unit and not carry out any modifications to the configured supplied by the party without the presence of the authorized Service Engineer.
- 11. The Bhagirathi Milk Union shall use only recommended Inks, make LINX, solvent, consumables and Spare parts. Any loss/damage to the system due to non-use of recommended consumables and spare parts will be excluded from the scope of this contract.
- 12. This contract specifically excludes damages caused due fire, theft, riots, accidents and other exceptional circumstances.
- 13.40% payment shall be made after acceptance of the contract, 30% after 6 months and the remaining 30% after successful completion of the contract.
- 14. In case of change of any hardware or any other spare parts the cost shall be borne by The Bhagirathi Milk Union but the damaged part must be returned to the Milk Union.
- 15. The Provisions specified in the contract shall not be omitted, added or amended in any case except in writing and duly signing by both the parties thereof. The party has no right to alter the terms and conditions specified in this contract.
- 16. Please note that during contract period if your work is not found satisfactory, we may discontinue the Annual Maintenance and Service Contract without assigning any reason thereon.
- 17. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
