- 1. List of Required items for Repair/Replacement is attached in Annexure A. The list may be verified by the party at his own cost prior to quoting the rates. Any item not mentioned in the list but essential to keep the system functional must be quoted by the bidder.
- 2. During evaluation the Committee may summon of the bidders and seek clarification/information regarding bids, credentials of execution of similar nature of work within the stipulated time frame, their proposals will be liable for rejection.
- 3. Inspection of materials may be undertaken at the supplier's premises whenever necessary by the Tendering Authority/ any officer authorized by the undersigned.
- 4. Materials refurbished, replaced or changed must cover warranty of 12 months from the date of successful commissioning of the installed unit from the principal company.
- 5. Supply, installation & commissioning of the ordered item with all accessories must be completed within 30 (thirty) days from the date of order. Trial run of the whole unit will be done in presence of Milk Union's authorized personnel. Trial run report shall be submitted duly signed by the authorized personnel.
- 6. **Penal Measure**: Time being the essence of the contract failure to supply the materials within due time or delay shall invite penalty. For violation of any terms and conditions of

the contract the Bhagirathi Milk Union reserves the right to cancel the contract without assigning any reason thereof.

- 7. **Place of Delivery**: The office of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Chaltia, Berhampore, Murshidabad, Pin-742165, West Bengal.
- 8. Conditional *and* incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender
- 9. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
- 10. The rate quoted by the bidder shall be inclusive of all taxes Excise Duty, GST and other charges/ taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.
- 11. Mode of transportation for the supply of the goods to our site will be arranged by the bidder.
- 12. Materials dispatched from the bidder until or unless reaches the Place of Delivery is the sole responsibility of the bidder. The Milk Union will not be responsible for any damage in transit, loading or unloading and no claim in this regard will be entertained.
- 13. Transit insurance of the goods will be the responsibility of the bidder and no claim regarding this will be entertained.
- 14. Unloading of goods and installation and commissioning shall be in the scope of the Milk Union
- 15. **Payment**: Payment shall be released on receipt of acknowledged copy of Invoice of the units in good condition, installation and commissioning and satisfactory working of the Analyzer and other components repaired as desired certified by the concerned personnel and approved by Competent Authority in the Bank Account of the supplier in NEFT/RTGS.
- 16. Taxes will be deducted as per Govt. norms.
- 17. The undersigned reserves the right to accept or reject any tenders and to cancel the entire tender process without assigning any reason whatsoever.
