3. Price quoted by the bidder should be inclusive of all taxes and levies in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.

4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
  - a. **Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.**
  - b. **GST Registration Certificate.**
  - c. **Rate as per format in FORMAT – A.**

Failure to submit the above mandatory documents shall lead to rejection of the Quotation.

5. Jobs must be completed within 7 days after placement of Work Order.
6. Payment shall be made in NEFT/RTGS after 30 days of receipt of the bill along with the submission of work completion Certificate duly certified by Competent Authority.
7. The materials used in the work must be standard and commercial grade. If materials supplied is found to be of substandard quality, material shall be rejected right away.
8. In case there is any discrepancy in quality, the Milk Union may impose a penalty and then accept the goods. In this case prior intimation shall be given to the supplier.
9. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.
10. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
