3. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited and in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.
4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
 - a. **Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.**
 - b. **GST Registration Certificate / Unregistered dealers may also participate but the GST amount will be deducted from the bill amount if applicable.**
 - c. **Rate as per format in FORMAT – A.**

Failure to submit the above mandatory documents shall lead to rejection of the Quotation.

5. The Welding job will be monitored by representative of Union and party awarded for the job.
6. Welding Job must be completed within 15 days after placement of Work Order.
7. Payment shall be made in NEFT/RTGS after 30 days after successful completion of the job certified by Competent Authority.
8. In case there is any discrepancy in quality of material and the Job, the Milk Union may impose penalty. In this case prior intimation shall be given to the Party.
9. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.
10. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
