The Bhagirathi Cooperative Milk Producers' Union Limited invites Online Tender (E-Tender) in two bid system for supply of 2000 kg Food Grade Citric Acid as per prescribed IS Standard 13186:1991.

#### **Earnest Money Deposit**

The EMD amounting to Rs. 2,000/- should be deposited online through Net Banking, NEFT/RTGS in favour of The Bhagirathi Cooperative Milk Producers' Union Limited payable at Berhampore.

EMD shall not carry interest.

Tenderers will select the Tender to bid and initiate payment of pre-defined EMD for that tender by selecting from either of the following payments modes (vide Finance DepartmentMemorandum no. 3975-F(Y) Dt. 28/07/2016):

- 1. Net banking (any of the banks listed in the ICICI Bank Payment gateway) in case of paymentthrough ICICI Bank Payment Gateway.
- 2. RTGS/NEFT in case of offline payment through bank accounts in any Bank.

## Payment procedure

- a) Payment by Net Banking (any listed bank) through IClCI Bank Payment Gateway:
- 1. On selection of net banking as the payment mode, the bidder will be directed to IClCI BankPayment Gateway webpage (along with a string containing a Unique ID) where he will select theBank through which he wants to do the transaction.
- 2. Bidder will make the payment after entering his Unique ID and password of the bank to processthe transaction.
- 3. Bidder will receive a confirmation message regarding success/failure of the transaction.
- 1. If the transaction is successful, the amount paid by the bidder will get credited in the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limitedmaintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road, Kolkata forcollection of EMD/Tender Fees.
- 2. For transaction failure, the bidder will again try for payment by going back to the first step.

#### b) Payment through RTGS/NEFT:

- 1. On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filledchallan having the details to process RTGS/NEFT transaction.
- 2. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT paymentusing his Bank account.
- 3. Once payment is made, the bidder Will come back to the e-Procurement portal after expiry of areasonable time to enable the NEFT/RTGS process to complete, in order to verify the paymentmade and continue the bidding process.
- 4. If verification is successful, the fund will get credited to the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road for collection of EMD/Tender Fees.

- 3. Hereafter, the bidder will go to e-Procurement portal for submission of his bid.
- 4. But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.

#### B. Refund/Settlement Process:

- i. After opening of the bids and technical evaluation of the same by the Quotation inviting authoritythrough electronic processing in the e-Procurement portal of the State Government, the Quotationinviting authority will declare the status of the bids as successful or unsuccessful which will bemade available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.
- ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through anautomated process, the EMD of the bidders disqualified at the technical evaluation to therespective bidders' bank accounts from which they made the payment transaction. Such refundwill take place within T+2 Bank Working Days where T will mean the date on which informationon rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority.
- iii. Once the financial bid evaluation is electronically processed in the e Procurement portal, EMD of the technically qualified bidders other than that of the L1 will be refunded, throughan automated process, to the respective bidders' bank accounts from which they made thepayment transaction. Such refund will take place within T+2 Bank Working Days where T willmean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the Quotation inviting authority.
- iv. If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurementportal and the information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.
- v. As soon as the Ll bidder is awarded the contract (AOC) and the same is processed electronically in he e-Procurement portal –
- a) EMD of the Ll bidder for tenders of State Government offices will automatically get transferredfrom the pooling account to the State Government deposit head "8443-00-103-001-07" throughGRIPS along with the bank particulars of the Ll bidder.
- b) EMD of the Ll bidder for tenders of the State PSUs/Autonomous Bodies/Local Bodies/PRIs, etc will automatically get transferred from the pooling account to their respective linked bankaccounts along with the bank particulars of the L1 bidder.
- In both the above cases, such transfer will take place within T+1 Bank Working Days where T willmean the date on which the Award of Contract (AOC) is issued.
- vi. The Bank will share the details of the GRN No. generated on successful entry in GRIPS with the E-Procurement portal for updation.
- vii. Once the EMD of the Ll bidder is transferred in the manner mentioned above, Tender fees, if any,deposited by the bidders will be transferred

	electronically from the pooling account to the Government revenue receipt head "0070-60-800-013-27" through GRIPS for Government tenders and to the respective linked bank accounts for State PSU/Autonomous Body/Local Body/PRIs, etc tenders.  viii. All refunds will be made mandatorily to the Bank A/c from which the payment of EMD (if any) were initiated.

- A. **Scope of Work:** Supply of Citric Acid packed in 25kg HDPC bags Monohydrate (U) ENSIGN (Cas No- 5949-29-1, GMO Free, GMP, HACCP, ISO 9001, ISO 14001, ASO 22000 or equivalent reputed brand).
- B. **Specification:** As per prescribed IS Standard IS 13186:1991

Technical Parameters: Grade:- Food grade

Colour: - White or colorless.

Odour:- Odourless

Form: - Crystalline solid.

**Purity: Min 99.5%** 

# **General Terms & Conditions**

- 1. Two part bid which consists of Technical & Financial bid separately.
- 2. The applicants must upload the credentials Statutory & Non Statutory documents in the Technical Folder. Nothing should be sent physically.
- 3. Financial quote must not be sent through post / physically.
- 4. The intending bidders are required to quote the rate online only. Financial Bid will contain rate of items only. No other document will be sent in the financial bid (Folder).
- 5. Bidder should quote unit price or price per kg of the material inclusive of all taxes and levies loading and unloading F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited.
- 6. EMD of the lowest successful bidder shall be converted to Security Deposit and shall be released after successful execution of the Contract. EMD of unsuccessful bidders shall be refunded from E-Tender portal as per norms.
- 7. The rate quoted by the bidder will be fixed for the quantity ascertained in this Tender Notice. No escalation in the rate would be considered.
- 8. Payment shall be made within 30 days in NEFT/RTGS on receipt of quality report of the supplied materials from Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the Competent Authority. If the materials received does not conform to the above prescribed standard then the materials shall not be accepted or rejected after joint inspection.
- 9. The documents submitted by the bidders online should be properly indexed & digitally signed. The NIT must be signed by the bidder as a token of acceptance of the terms and conditions stipulated in this Tender.
- 10. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/manufactured/ fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The Bhagirathi Cooperative Milk Producers' Union Ltd. reserves the right to cancel the N.I.T. at any time without showing any reason and no claim in this respect will be entertained.
- 11. Lowest Bidder must provide Food Grade Certificate and Certificate of Analysis prior to supply or during supply.
- 12. Materials must be delivered within 7-10 days after the Contract is awarded. Time being the essence of contract no variation shall be permitted in the delivery time. If the supplier fails to supply within 7 to 10 days, The Bhagirathi Milk Union Ltd. shall reserve the right to cancel the order besides forfeiture of Security Deposit and the loss shall be recovered from the party.
- 13. One termination of contract, the Security Deposit is liable to be forfeited and any of the resultant loss beyond Security Deposit will be recovered from the contractor by legal means apart from forfeiture of any amount due to the bidder.

- 14. If there is any complaint regarding the **quality/ damage / short supply / failure of schedule date delivery** etc. you will be responsible for replacement and if the Milk Union makes an alternative arrangement from another supplier the cost of such item would be deducted from the bill amount, Security Deposit whichever applicable.
- 15. Place of Delivery: The Store Section of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Chaltia, Berhampore, Murshidabad, Pin-742165, West Bengal.
- 16. Conditional and incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender
- 17. Before issuance of the SUPPLY ORDER, the tender inviting authority may verify the original credential(s) and/ or other document(s) of the lowest bidder with original documents, if found necessary. After verification, if it is found that the document(s) submitted by the lowest bidder is/are either manufactured or false, the work order will not be issued in favour of the said Bidder and security deposit will be forfeited.
- 18. The rate quoted by the bidder shall be inclusive of all taxes packing, forwarding, Excise Duty & GST loading and unloading charges and other charges/ taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.
- 19. Mode of transportation for the supply of the goods will be arranged by the supplier.
- 20. The accepting authority (The Bhagirathi Cooperative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
