- 3. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.
- 5. The bidders participating in the quotation are requested to provide GST Registration Certificate along with the price bids.
- 6. Time being the essence of contract materials must be delivered within 10 days after placement of Supply Order.
- 7. Payment shall be made in NEFT/RTGS after 20 days of receipt of the bill along with the materials in good condition certified by competent authority.
