Taxes will be deducted from the transport bill, as per Govt. norms. Toll tax and other levies will be paid by milk union, on actual basis, against submission of receipt.

GENERAL TERMS AND CONDITIONS

- 1. The rate shall be quoted for a single vehicle inclusive of all (Fuel, Lubricant, driver, helper and maintenance cost etc.), per km basis.
- **2.** Toll taxes and levies will be borne by the Milk Union against submission of original receipt.
- **3.** The Bhagirathi Co-operative Milk Producers' Union Limited will not accept any variation in conditions stipulated in the tender. Any suggestion in the tender, for any modification of the conditions of tender will not be entertained and also the conditional offer in tender will not accepted and treated as invalid tender.
- **4.** The proposed vehicle which will be provided for transportation must be in good condition. Preference will be given to new vehicle not more than 3 years old. Route/ Operation area of the transporter may change during service periods as per requirement of the Milk Union.
- **5.** The transporters or his representative (Driver / Helper) shall be responsible for collecting cheques/drafts/letters/ and other related materials / documents from distributors / dairy cooperative society/ etc and submitting it to the In-Charge/Route In-Charge of the concerned section.
- **6.** If the tenderer has already been blacklisted by any Government/ Government Undertakings/ Co-operative societies, his tender will be rejected. In case information about such black listing comes to the knowledge of the Union after awarding of the tender, the contract will be terminated and liquidated damages also levied, apart from taking penal action.

- **7.** BCMPUL reserves the right to accept or reject any or all tender wholly / partly without assigning any reason thereof.
- **8.** Successful bidder has to provide Vehicle within 30 days of acceptance of Work Order. Failure to engage vehicle with in this stipulated time period shall lead to termination of contract.
- **9.** Bhagirathi Milk Union reserves the right to reject any bid of transporter whose reputation was bad or not satisfactory once with the Milk Union.

OTHER TERMS AND CONDITIONS

- 1. The Transporter shall liable to collect, carry and hand over the Milk Products, Milk Crate, Milk Cans, Lid, Milk Testing Equipments along with others material, documents etc to the said Dairy Cooperative Society /distributor etc. The contract will be valid from April' 2020 to March' 2021 and the Transporter shall be liable to provide the service for the stipulated time period. If required, tenure may be extended further for period of (3) three months.
- **2.** At the time of milk collection, the transporter should record the number / quantity of filled milk cans at Milk Union in the prescribed / supplied format and it will be submitted to the Union office in time. The transporter should also deliver the report (Truck Sheet) of received milk from Dairy Cooperative Societies.
- **3.** During the contract period, no escalation of rate for vehicle, including fuel, lubricant, toll tax, levies, maintenance cost etc. along with driver and helper will be entertained. For any damage or repair works to the vehicle will be borne by the Transporter and will not be borne by the Milk Union. In case of abrupt change in the fuel price the rate escalation or de-de-escalation may be done by the management at its sole discretion issuing an order and no claim in this regard shall be entertained.
- **4.** That the transporter shall carry the Milk, Milk Cans, Cattle Feed, Milk Testing Equipment, letters, and documents of the Bhagirathi Milk Union, according to the scheduled Time Table from pickup point to deliver point i.e. to the proper address/consignee/ addressee/Milk Union or any other place as per instruction. If necessary the Transporter shall carry the Milk or Milk Product from Dairy to Agent/Society as per instruction of Milk Union as per prescribe Route & prescribed time. If the Transporter is unable to perform so, penalty will be imposed as decided by the Milk Union against each failure.
- **5.** As per instructions Milk, Milk Cans, Cattle Feed, Milk Testing Equipment, Letters and Documents are to be transported by milk vehicles to the milk union. The transporter of the Milk vehicle will be liable to maintain the record. If the transporter fails to fulfill the aforesaid responsibilities due to any reason, which causes any economic loss which is detrimental to the reputation of Milk Union then the transporter will be compelled to compensate the penalty an amount as decided by the Milk Union against each fault and that will be deducted from the monthly bill of the transporter.
- **6.** If for the unavoidable circumstances the Milk Union is compelled to stop the milk collection at any Milk Route at any shift. Bhagirathi Milk Union shall not be liable to pay the compensation. The Transporter shall have to abide by such order. Bhagirathi shall inform occurrence of such situation well ahead in advance.
- 7. The Transporter will be fully responsible for Milk Transportation. The Transporter shall also arrange for immediate replacement of the vehicle in the event of accident /break down of the vehicle deployed by him and intimating both orally and writing to officials of Bhagirathi Milk

Union and ensure that the service is not affected due to such accident / breakdown. If the Transporter is unable to replace the vehicles in the above situation, penalty will be imposed an amount as decided by the Milk Union against each fault and the amount shall be deducted from the monthly bill of the transporter.

- **8.** That the Transporter will have to affix this permanently by red colour "ON EMERGENCY DUTY" BHAGIRATHI MILK UNION Name & Logo on the body of vehicle.
- **9.** The Bhagirathi Milk Union shall have absolute right to check the vehicle at any time through its designated officials. In an unfortunate case of accident of the vehicle, liability will be activated according to the law of Motor vehicle Act.
- **10.**The transporter shall not use his vehicle for any other activities, like transportation of other products /materials, other than the products / materials that specified by milk Union. In such event, Bhagirathi Milk Union has reserves the right to impose penalty an amount as decided by the Milk Union.
- **11.**That the Bhagirathi Milk Union reserves right to increase or decrease the number of Societies and distance of the Milk Route. In that case, same rate p/km will be prevail.
- **12.**The transporter has to submit the transport bill in (triplicate) within 7th day of the month and accordingly bill shall be paid within 21^{to} 30 days of the submission of bill. In case of failure to submit the bill within 7th day of succeeding month, the Union shall not be responsible for any delay in paying monthly bill. Income Tax will be deducted as per Govt. Norms.
- **13.**The Bhagirathi Milk Union shall debar the transporter or its staff / helper on account of negligence / nuisance during transportation of milk. If it is found to involve in the activities like Theft, Fraud, Dishonesty, Gross negligence, misconduct etc. Severe penalty shall be imposed which may further lead to termination of contract and forfeiture of security deposit and transporter shall be further blacklisted for 3 years.
- **14.** The Bhagirathi Milk Union shall reserves the right to instruct the transporter to collect the Milk, Milk Cans and other materials in another route apart from route fixed to him / her, according to the time table relating to that particular Route. He/she also responsible to deliver such items to the reception point.
- **15.** Without prior permission of Milk Union, the transporter shall have no right to park the Milk carrying vehicle at Union premises. Penalty shall be imposed for using water without prior approval of the concerned official / competent authority.
- **16.**The timetable for milk collection shall be fixed by Bhagirathi Milk Union .The Transporter shall have to follow the scheduled timetable for collecting filled or empty Cans, Milk & milk Product from receiving / end point.
- **17.**If for any reason the transporter does not agree to move the vehicle as a result of which the Milk Union incurs loss, the loss shall be recovered from the transporter by deducting of the said amount from security amount or bill and penal action shall be taken for breach of contract.
- **18.**The Transporter shall be liable to submit time to time up-to-date copies of all statutory documents i. e. Vehicle Registration Certificate/Card, Tax Receipt, vehicle Fitness certificate, Road permit, Insurance, Driving License etc. as and when required and also renewed before its expiry, without fail.

- **19.**After settlement of tender if the Transporter is unable to supply the vehicle and the Transporter will declared unfit to participating in tendering process of the Milk Union for next two years.
- **20.**If any kind of doubt / dispute arises regarding the contract or its briefing, both parties can appeal to the arbitrator. In this case the arbitrator will be Chairman / Special Officer of the Milk Union or any representative nominated by them. For any legal issue, Jurisdiction must be Murshidabad.
- **21.**The Bhagirathi Milk Union shall debar the transporter and its staff if found involved in activities like theft. Fraud, Dishonesty, Bad behavior with Union representative and unholy tie-up with any person. Suitable measures shall also be taken in accordance to law.
- **22.**The transporter shall be liable to follow the instructions provided by the Milk Union from time to time.
- **23.**At the time of transporting full or empty Cans and Society/Milk Union related materials the transporter shall not be allowed to transport any other materials. If the Transporter is found to involve in such activities, penalty shall be imposed to the contractor.
- **24.**The Vehicle must be insured according to Insurance Act.
- **25.**Without the permission of Milk Union the contractor shall not be allowed to change the type of vehicle other than the one specified in the contract. Sub-contracting will not be allowed.
- **26.**Force Majeure: For any unforeseeable circumstances like strike, lock out, Closer, Flood, Natural Calamities etc for which the Milk Union is compelled to stop Milk Collection or the transporter is unable to ply his / her vehicle it shall termed as Force Majeure and no claim by transporter or no penal action in this regard.
- **27.**This is fully commercial contract and not the contract of appointment. There is no relation of staff and Employer within Union and Contractor. All the statutory liabilities shall be implemented time to time. The Transporter shall be compelled to abide by all the conditions.
- **28.**The Transporter shall have to cover the Milk Cans by Jute Sack during the summer season if necessary as and when so decided by the Milk Union to be intimated in advance. The cost shall be borne by the transporter.
- **29.**If the service of the transporter found unsatisfactory and violating any of the terms and conditions of the agreement, the Milk Union reserves the right to terminate his/her contract any time without assigning any reason whatsoever and security deposit shall be forfeited. Due to any other reason i.e. if the service of the transporter is no more required, then Bhagirathi Milk Union will not be liable to pay any kind of compensation / demurrage to the Transporter for the respective day or for the stipulated time period or rest periods.
- **30.**The vehicle used by the transporter to transport milk, milk can, cattle feed and milk products should comply with the Motor Vehicle Act. In case of any kind of fine will be levied by the Govt. on the Transport vehicle, that amount shall be borne by the transporter.
- **31.**No loading or unloading charges will be paid to the transporter. In addition to this in case of Procurement enhancement, the transporter will have to engage an extra vehicle for which payment shall be made at the same rate or the rate decided by the Union.

- **32.**The transporter shall collect the filled Milk cans from Dairy Cooperative Society level and after unloading the milk filled cans it shall return to the Dairy Cooperative Society in schedule time. Any loss or damaged caused to the Milk Can / Lid, any pilferage, theft during the process of transportation shall be recovered from the Transporter with penalty.
- **33.**Either party may terminate the contract by giving three month notice in advance. If the service of the transporter is not found satisfactory or it is adverse to the interest of the Milk Union, then the Bhagirathi Milk Union may terminate the contract at any point of time, on termination of contract, the Security Deposit will be forfeited.
- **34.**The Transporter has to pay Security Deposit of Rs.20000/- (refundable & interest free) for each vehicle. An additional Security Deposit of Rs.5000/-has also to be deposited for Supply of GPS Tracker and refundable subject to return of GPS Tracker in working Condition after execution of the contract. In default, Security Deposit shall be deducted from the transport bill. GPS Tracker must be active during the trip.
- **35.**Rate quoted by transporter per km basis shall be variable proportionately on monthly basis, against the increase or decrease average monthly fuel rate.
- **36.** Vehicle shall play in both morning shift & evening shift (details are enclosed in financial bid format). Toll tax and other levies will be paid by milk union, on actual basis, against submission of original receipt.

Precautions:

- 1. The tenderer must satisfy himself / herself thoroughly about the geographical area to be covered, nature of work, local conditions and the requirement of the Union, before submitting his/her tender.
- **2.** The person signing the tender should be the Proprietor / Partner / Managing Director or any other person duly authorized to sign the tender document. In the latter case, valid authorization letter should be attached.
- **3.** The tenderer should read every page and understand the implications fully and offer the tender only if he could discharge the obligations set out in the tender documents.
- **4.** On selection, the Contractor has to execute an agreement on a Non-Judicial Stamp Paper worth Rs.100 the general terms and condition & other terms and conditions mentioned in the NIT.
