3. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.
5. The bidders participating in the quotation must provide the GST Registration Certificate along with the price bids.
6. Time being the essence of contract materials must be delivered within **10** days after placement of supply Order. Failure to supply the material within stipulated date as mentioned in Purchase Order shall lead to the cancellation of Purchase Order.
7. Payment shall be made in NEFT/RTGS after **30** days of receipt of the bill along with the materials in good condition certified by competent authority.
8. The Milk Union shall verify the sample before issuance of the Purchase Order. The material supplied must conform the sample supplied. Material not conforming the sample shall not be accepted and not payment in this regard shall be released.
9. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding upon the party.
10. Subletting of the contract shall not be allowed and any person or company involved in it shall be blacklisted and debarred from participating in the tender for the next 3 years.
