- 2. Quotation shall only be accepted in sealed envelope subscribing the Memo No. and Scope of Work. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 3. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R Kandi Chilling Palnt, Kandi, Murshidabad. No escalation in price will be considered after submission of bids.

- 4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
  - a. Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.
  - b. GST Registration Certificate / Unregistered dealers may also participate but the GST amount will be deducted from the bill amount if applicable.
- 5. Time being the essence of contract the job must be completed within 10 days after placement of Work cum Supply Order.
- 6. Payment shall be made in NEFT/RTGS within 30 days after satisfactory completion of the job certified by competent authority.
