

Terms and Conditions:-

1. There should be no alteration in the tender documents Bidders are required to quote their rate following the specified specifications, terms, and conditions.
2. Bidders should furnish **GST Registration Certificate** along with bid.
3. In case of non GST registered Bidders the GST will be deducted as per Government Norms
4. Any other taxes and Levies will be deducted as per Govt. norms.
5. The Bidder must quote their rate inclusive of all taxes F.O.R. The Bhagirathi Milk Union.
6. Payment shall be made after **10 to 15 days** of delivery of the goods and receipt of the same at the store in the good condition.
7. Conditional or incomplete tenders are liable to be rejected.
8. Delivery of the material should be complete within 10 days after placement of supply Order in 3 consignment per month delivery schedule will be informed to the supplier .
9. For delay in supply of goods within stipulated date and time a liquated damage of 0.5% will be imposed per week subject to maximum of 10% of the contract value and the amount will be deducted from the bill.
10. Violation of terms and condition or extreme delay in supply which may hamper the day to day activities of milk union may lead to the termination of contract after 3 remainders.
11. During the tenure of supply price escalation will not be applicable.
12. The Milk Union reserves full right to accept or reject any tender or cancel the entire tender process without assigning any reason thereof.
