- 3. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited. No escalation in price will be considered after submission of bids.
- 5. The bidders participating in the quotation are requested to provide GST Registration Certificate along with the price bids.

- 10.If the material received is found faulty or possess any manufacturing defect as a result of poor workmanship within a month or two then it has to be replaced by the party.
- 11.In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
