The bid shall be submitted in The Bhagirathi Cooperative Milk Producers’ Union Limited., Feeder Dairy, Panchanantala, Berhampore, Murshidabad.

Validity of the bid: The bid once submitted will be valid for 90 days.

Supply Schedule: The selected bidder must complete his supply within 20 from the date of issuing Work Order.

Other Terms & Conditions:

1. Two part bid which consists of Technical & Financial bid separately.
2. Payment shall be made within 25-30 days in NEFT/RTGS on receipt of **quality report** of the supplied materials from Requisitioning Authority & on submission of bill in duplicate along with the received challans from the Competent Authority.

3. The documents submitted by the bidders online should be property indexed & digitally signed.
4. During the scrutiny, if it comes to the notice to the tender inviting authority that the credential(s) and/or any other paper(s) has/have been of any bidder found incorrect/manufactured/fabricated, that bidder will not be allowed to participate in the tender process and that application will be rejected outright. The Bhagirathi Cooperative Milk Producers' Union Ltd. reserves the right to cancel the NIT at any time without showing any reason and no claim in this respect will be entertained.
5. Time being the essence of contract no variation shall be permitted in the delivery time as prescribed in the delivery schedule. If the bidder fails to supply and execute the work in full or part of order as per delivery schedule, The Bhagirathi Milk Union Ltd. shall reserves the right to cancel the order and the loss shall be recovered from the party.
6. Supplied materials must adhere to the prescribed specification and sample provided during bid submission. If materials supplied does not conform the prescribed specification and sample, material shall not be accepted and no claim in this regard shall be entertained.
7. Place of Delivery: The Store Section of The Bhagirathi Co-operative Milk Producers' Union Ltd., Feeder Dairy, Panchanantala, Berhampore, Murshidabad, Pin- 742165, West Bengal.
8. Tender of any blacklisted party shall not be taken into consideration.
9. Conditional and incomplete tender will not be entertained. Violation of one or more clause will result in rejection of the tender.
10. The accepting authority (The Bhagirathi Co-operative Milk Producers' Union Ltd.) reserves the right to reject any or all the tenders without assigning any reason whatsoever and will not be bound to accept either the lowest tender or any of the tenders.
11. Before issuance of the SUPPLY ORDER, the tender inviting authority may verify the original credential(s) and/ or other documents of the lowest bidder with original documents if found necessary. After verification if it is found that the documents submitted by the lowest bidder is/are either manufactured or false, the work order will not be issued in favour of the said Bidder and the said bidder shall be blacklisted.
12. The rate quoted by the bidder shall be inclusive of all taxes packing, forwarding, GST loading and unloading charges and other charges/taxes if any for the delivery of the goods in the office of The Bhagirathi Cooperative Milk Producers' Union Ltd.
13. Mode of transportation for the supply of the goods will be arranged by the supplier.
14. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
