1. **Statutory documents:** Bidder shall submit latest GST Registration Certificate, copy of valid PAN Card, credential of execution of similar nature of work and supply.

Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as “**BID for for Overhauling of Two Nos. IBR Boiler along with Procurement of Consumable items.**”

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers’ Union Limited, Feeder Dairy, Panchanantala, Chaltia-742165, Berhampore, Murshidabad.

**Validity of the bid:** The bid once submitted will be valid for 60 days.

**Delivery/ Job completion Period:** Supply and job to be completed within 20 days from the date of acceptance Work Order.

**Other Terms & Conditions:**

1. The bidders are required to submit their tender before last date and time of submission. No bids will be accepted for evaluation after last date and time of bid submission.
2. Partial/incomplete tenders are liable to be rejected. The tender documents should be properly indexed and signed and sealed by the bidder.
3. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding, IBR statutory charges of two numbers Boiler and transportation charges & FOR dairy.
4. Time being the essence of contract; supply and job must be completed within 20 days after placement of Work cum Supply Order.
5. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in completion of job and supply of goods subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the consignment arranged from the different source shall be deducted from the party.
6. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as “Force Majeure” and penalty clause will not be applicable.
7. Payment will be made in NEFT/RTGS after 20-30 days after satisfactory completion of job and delivery of goods followed by submission of bills certified by sectional In-Charge and approved by competent authority. The bank details of the party are to be mentioned in the bills clearly.
8. The Requisitioning Authority will certify the quality of goods received at the store. In case if any consignment is not conforming prescribed specification and quality, penalty shall be imposed and the cost will be deducted from the bill accordingly.
9. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
10. The Milk Union reserves the right to cancel the Order if the party fails to completed the job and supply the goods in due time or compromises with the Scope of Work and in quality of the goods.

**The Managing Director of The Bhagirathi Cooperative Milk Producers’ Union Limited reserves the right to reject or cancel any bid or the entire tender process at any point of time without assigning any reason thereof.**

- V. Fitting of all valves, Fusible Plugs.

- VII. Setting of safety valves.
