- 1. - 2. The last date and time of submission of quotation documents is **22.08.2019**, 15.00 hours in the office of The Bhagirathi Cooperative Milk Producers' Union Limited.
- 3. Quotation shall only be accepted in sealed envelope subscribing the Memo No. and Scope of Work. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
- 4. Price quoted by the bidder should be inclusive of all taxes levies packing, and forwarding F.O.R Domkal Chilling Plant, Bhatshala, Bashantapur, Domkal, 742303. No escalation in price will be considered after submission of bids.

- 5. The bidders participating in the quotation must provide GST Registration Certificate along with the price bids.
- 6. Time being the essence of contract the job must be completed within 20 days after placement of Work cum Supply Order.
- 7. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in supply of goods subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills. If the Milk Union makes alternative arrangements due to negligence of the party, the cost of the contract arranged from the different source shall be deducted from the party.
- 8. Force Majeure: For delay in completion of the work for which neither the supplier nor the Milk Union is responsible like strikes, lockouts, war, catastrophe etc. shall be termed as "Force Majeure" and penalty clause will not be applicable.
- 9. Payment shall be made in NEFT/RTGS within 30 days of receipt of the bill along with the materials in good condition certified by competent authority.
- 10. If the material received is found faulty or possess any manufacturing defect as a result of poor workmanship within a month or two then it has to be replaced by the party.
- 11. Certificate from Authorized Water Testing Laboratory must be provided after successful completion of the job along with bill. Failure to submit Water Testing Certificate shall invite penalty and payment shall be withheld.
- 12. Performance Guarantee of Rs. 10,000/- shall be applicable on the bid and the amount shall be released after 1 year from successful commissioning of the plant.
- 13. The bidder must undergo site Inspection during office hours before quoting of bid.
- 14. Any material not mentioned in the notice but essential for execution of the contract must be quoted by the bidder.
- 15. The job must be done at Domkal Chilling Plant, Bhatshala, Bashantapur, Domkal, 742303.
- 16. The bids quoted shall remain for a period of 60 day(s).
- 17. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.
- 18. Supplied items must cover a minimum Warranty of 1 year from the Principal Company from the date of installation.
