NAME OF THE WORK: REPAIRING OF WATER SOFTENING PLANT AT FEEDER DAIRY

Offline tenders are invited by The Bhagirathi Cooperative Milk Producers' Union Limited in two bid system from reliable, resourceful, bonafide and experienced firms / companies / individual contractors having requisite financial capability and sufficient experience in execution of similar nature of jobs mentioned above

Scope of Work:

Repairing of Water Softening Plant at Feeder Dairy. The Scope of Work includes supply of goods and Services which comprises of the following:

Scope of Supply (for 13 KLPH Capacity softener):

- 1) 150 Cu ft Media for Iron Removal Filter
- 2) 500 Lit Ion Exchange Resin
- 3) Necessary Nut Bolts, Gaskets

Scope of Services (for 13 KLPH Capacity softener):

- 1) Unloading old Media from Iron Removal Tank and Resin Exchange Tank
- 2) Loading fresh Media in Iron Removal Tank and Resin Exchange Tank
- 3) Checking all operating valves and necessary corrections accordingly
- 4) Testing report to be submitted for soft water generated after replacement of media.
- 5) Transportation of media to be arranged within the scope.
- 6) Total job has to be done without hampering the supply of soft water.

Eligibility Criteria & Mandatory Documents:

Experience: Bidder should have at least 3 (three) years of experience in execution of similar nature of jobs as notified in this Tende. Work Order value Rs. 2,00,000/- should be executed by the party within the last three years and Work Completion certificate/Work Order from a competent authority should be submitted in support of the claim.

Statutory documents:

- 1. Bidder shall submit latest GST Registration
- 2. Copy of valid PAN.
- 3. Work Completion Certificate

All the above-mentioned criteria and documents are mandatory and if the bidder fails to submit any of them, their bid will summarily be rejected.

Submission of bids: The bids will be submitted in offline mode.

Technical bid submission:

All the mandatory documents namely

- 1. Work completion certificate/Work Order from competent authority worth Rs. 2.0 lakhs
- 2. EMD
- 3. GST Registration
- 4. Copy of valid PAN

Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as "BID FOR REPAIRING OF WATER SOFTENING PLANT".

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited.

Validity of the bid: The bid once submitted will be valid for 90 days.

Work Completion Schedule: The selected bidder must complete the job successfully within 30 days from the date of issuing Purchase Order.

Other Terms & Conditions:

- 1. No cost escalation after receiving of bids shall be entertained.
- 2. Subletting of work is not allowed.
- 3. Liquidated damage of 0.5% per day with a maximum of 10% on the Total value of Purchase Order shall be imposed if there is any delay in supply of goods and the resultant amount shall be deducted from the Security deposit and the Bill.
- 4. Installation and Commissioning and Trial run shall be in the scope of the bidder.

- 5. Payment Terms: Payment shall be released within 25-30 days in NEFT/RTGS after successful completion of the job duly approved by the competent authority. If there is a manufacturing defect in the material supplied as a result of poor workmanship, the supplied material must be immediately replaced.
- 6. The Supplier must provide documents like operation brochure, guarantee/warranty papers of the supplied materials during the time of supply of the items.
- 7. If there is any delay in supply of the material during the scheduled time after the Work Order has been given the contract shall be deemed to be cancelled.
- 8. Failure to submit the Technical bid documents shall lead rejection of the bid.

The bid inviting authority reserves the right to reject or cancel any bid or cancel the entire tender process at any point of time without assigning any reason whatsoever.
